#### STANDARD BID CONDITIONS

#### PT 14-04

- 1. ACCEPTANCE AND REJECTION: The Arkansas State Highway and Transportation Department (AHTD) reserves the right to reject any or all bids, to accept bids in whole or in part (unless otherwise indicated by bidder), to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the State.
- 2. **PRICES:** Unless otherwise stated in the Bid Invitation, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified (feet, each, lbs., etc.), (3) prices must be F.O.B. destination specified in bid, (4) prices must be firm and not subject to escalation, (5) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit prices shall govern. Discounts from bid price will not be considered in making awards.
- BID BONDS AND PERFORMANCE BONDS: If required, a Bid Bond in the form of a cashier's check, certified check, or surety bond issued by a surety 3 company, in an amount stated in the Bid Invitation, must accompany bid. Personal and company checks are not acceptable as Bid Bonds. Failure to submit a Bid Bond as required will cause a bid to be rejected. The Bid Bond will be forfeited as liquidated damages if the successful bidder fails to provide a required Performance Bond within the period stipulated by AHTD or fails to honor their bid. Cashier's checks and certified checks submitted as Bid Bonds will be returned to unsuccessful bidders; surety bonds will be retained. The successful bidder will be required to furnish a Performance Bond in an amount stated in the Bid Invitation and in the form of a cashier's check, certified check, or surety bond issued by a surety company, unless otherwise stated in the Bid Invitation, as a guarantee of delivery of goods/services in accordance with the specifications and within the time established in the bid. Personal and company checks are not acceptable as Performance Bonds. In some cases, a cashier's check or certified check submitted as a Bid Bond will be held as the Performance Bond of the successful bidder. Cashier's checks or certified checks submitted as Performance Bonds will be refunded shortly after payment has been made to the successful bidder for completion of all terms of the bid; surety bonds will be retained. Surety bonds must be issued by a surety company authorized to do business in Arkansas, and must be signed by a Resident Local Agent licensed by the Arkansas State Insurance Commissioner to represent that surety company. Resident Agent's Power-of-Attorney must accompany the surety bond. Certain bids involving labor will require Performance Bonds in the form of surety bonds only (no checks of any kind allowed). In such cases, the company issuing the surety bond must comply with all stipulations herein and must be named in the U.S. Treasury listing of companies holding Certificates of Authority as acceptable sureties on Federal Bonds and as acceptable reinsuring companies. Any excess between the face amount of the bond and the underwriting limitation of the bonding company shall be protected by reinsurance provided by an acceptable reinsuring company. Annual Bid and Performance Bonds on file with E & P Division must have sufficient unencumbered funds to meet current bonding requirements, or the bid will be rejected, unless the balance is submitted as set forth above, prior to bid opening.
- 4. TAXES: The AHTD is not exempt from Arkansas State Sales and Use Taxes, or local option city/county sales taxes, when applicable, and bidders are responsible to the State Revenue Department for such taxes. These taxes should not be included in bid prices, but where required by law, will be paid by the AHTD as an addition thereto, and should be added to the billing to the AHTD. The AHTD is exempt from Federal Excise Taxes on all commodities except motor fuels; and excise taxes should not be included in bid prices except for motor fuels. Where applicable, tax exemption certificates will be furnished by the AHTD.
- 5. "ALL OR NONE" BIDS: Bidders who wish to bid "All or None" on two or more items shall so stipulate on the face of bid sheet; otherwise, bid may be awarded on an individual item basis.
- 6. SPECIFICATIONS: Complete specifications should be attached for any substitution or alternate offered, or where amplification is necessary. Bidder's name must be placed on all attachments to the bid.
- 7. **EXCEPTIONS TO SPECIFICATIONS:** Any exceptions to the bid specifications must be stated in the bid. Any exceptions to manufacturer's published literature must be stated in the bid, or it will be assumed that bidder is bidding exactly as stated in the literature.
- 8. BRAND NAME REFERENCES: All brand name references in bid specifications refer to that commodity or its equivalent, unless otherwise stated in Bid Invitation. Bidder should state brand or trade name of item being bid, if such name exists.
- FREIGHT: All freight charges should be included in bid price. Any change in common carrier rates authorized by the Interstate Commerce Commission will be adjusted if such change occurs after the bid opening date. Receipted common carrier bills that reflect ICC authorized rate changes must be furnished.
- 10. SAMPLES, LITERATURE, DEMONSTRATIONS: Samples and technical literature must be provided free of any charge within 14 days of AHTD request, and free demonstrations within 30 days, unless AHTD extends time. Failure to provide as requested within this period may cause bid to be rejected. Samples, literature and demonstrations must be substantially the same as the item(s) being bid, unless otherwise agreed to by AHTD. Samples that are not destroyed will be returned upon request at bidders expense. Samples from successful bidders may be retained for comparison with items actually furnished.
- 11. **GUARANTY:** Unless otherwise indicated in Bid Invitation, it is understood and agreed that any item offered or shipped on this bid shall be newly manufactured, latest model and design, and in first class condition; and that all containers shall be new, suitable for storage or shipment and in compliance with all applicable laws relating to construction, packaging, labeling and registration.
- 12. BACKORDERS OR DELAY IN DELIVERY: Backorders or failure to deliver within the time required may constitute default. Vendor must give written notice to the AHTD, as soon as possible, of the reason for any delay and the expected delivery date. The AHTD has the right to extend delivery if reasons appear valid. If reason or delivery date is not acceptable, vendor is in default.
- 13. DEFAULT: All commodities furnished will be subject to inspection and acceptance by AHTD after delivery. Default in promised delivery or failure to meet specifications authorizes the AHTD to cancel award or any portion of same, to reasonably purchase commodities or services elsewhere and to charge full increase, if any, in cost and handling to defaulting vendor. Applicable bonds may be forfeited.
- 14. ETHICS: "It shall be a breach of ethical standards for a person to be retained, or to retain a person, to solicit or secure a State contract upon an agreement of understanding for a commission, percentage, brokerage, or contingent fee, except for retention of bona fide employees or bona fide established commercial selling agencies maintained by the contractor for the purpose of securing business." (Arkansas Code, Annotated, Section 19-11-708).

#### PURPOSE OF SPECIFICATIONS

This item shall be a vehicle suitable for public transportation. The intent for these specifications is to set-forth the minimum performance for a commercial paratransit van with an option for to be fully ADA compliant. The vehicle shall be a conversion of an extended van, which will be used to transport elderly and disabled persons living in urban and rural areas. Vehicle shall be available as a fixed seat passenger vehicle or offered as an optional wheelchair lift-equipped version with one or two securement areas. This vehicle shall accommodate various seating combinations for both ambulatory and wheelchair passengers and will be required to operate on all types of neighborhood streets and rural roads with frequent starts and stops.

All manufacturing modifications, equipment, devices, materials, warranties, miscellaneous items, etc. which the manufacturer customarily and routinely applies to the vehicle shall be included. No advantage shall be taken by the manufacturer in the omission of any part or detail, which goes to make the vehicle complete and ready for service, even though such parts or detail are not mentioned in these specifications. Vehicle and modifications must comply with all Federal Motor Vehicle Safety Standards. All equipment provided must meet or exceed State and Federal requirements applicable to the equipment. All parts not specifically mentioned which are necessary in order to provide a complete vehicle, shall, at a minimum, conform in strength, quality of material and workmanship to what is provided by the automotive industry generally. All equipment and parts shall be new. This vehicle when equipped, shall meet all ADA requirements for a paratransit demand response vehicle.

<u>Dealer shall have as part of the documentation with receipt of each vehicle, a form with a detailed</u> listing of the warranties on the vehicle, conversion and ordered options.

Second Stage Manufacturer shall be certified as an acceptable body modifier for the OEM chassis proposed for modification.

#### **CLASSIFICATION OF VEHICLE**

The vehicle used for this conversion shall be a new, unused, current production model Ford or Chevrolet commercial **one ton van**, incorporating the latest engineering change, the GVWR shall be sufficient to accommodate all modifications and maximum passenger loading. The vehicle shall provide maximum passenger appeal in appearance, comfort, safety and economy of operation.

#### A. Principal Specifications:

- 1. <u>Air conditioning</u>: Shall have the OEM's largest BTU system available and have a second unit for rear compartment with a minimum rating of 30,000 BTUs using a <u>two fan</u> skirt mounted condenser. All hoses, fittings, and clamps shall comply with SAE specification J2064 Type D and be of a Quick-Click design or equivalent.
- 2. <u>Alternator</u>: OEM Heavy duty, capable of no less than 225 amps at maximum output.
- 3. <u>Automatic Speed Control</u>: Shall have factory cruise control installed.
- 4. <u>Battery</u>: Shall have a dual battery system with a minimum of 1250 cold cranking amps at 0° F. If battery is mounted on side of frame rail then van shall have a decal on body to show the battery location.
- 5. **Brakes**: Power front and rear disc with four-wheel anti-lock.
- 6. **<u>Bumpers</u>**: Shall have both front and rear as supplied by OEM in the standard available finish.
- 7. Chassis: Shall have a minimum wheelbase of 135" and an overall length of 215".
- 8. <u>Cooling System</u>: Heavy duty, including heavy duty, extra capacity radiator, and factory installed coolant recovery system.
- 9. <u>Dome Cap</u>: Shall be of a style and design, which provides for the "Ambulatory Passenger Door style, wide type" entrance doors, with minimum wind resistance. Style and design shall be subject to approval by the Department. The raised roof dome cap shall provide a minimum center aisle height of 75". Installation shall be performed to ensure the original manufacturer's side body integrity and impact strength. Cap shall be designed, constructed, and installed to ensure the maximum rollover protection required by the federal and state motor carrier safety regulations. Raised roof dome cap shall be insulated with fiberglass mats or equivalent to the maximum extent possible. A placard shall be installed in a location clearly visible to the driver stating the appropriate height restriction for the vehicle.
- 10. Door, Passenger Front Entrance: Shall have an ambulatory passenger door (APD style, Wide-Type and must be FMVSS 206 Compliant) minimum 25"X85" with an electrical/mechanical power that allows operation by a dash-mounted switch. Power opener shall provide a smooth operation throughout the open and close cycle and shall be integrated with OEM vehicle dash and latch mechanism. Must be designed to allow ease of troubleshooting and field maintenance and have an integrated manual backup system in the event of electrical or mechanical failure. The step and well shall be designed and constructed of corrosion resistant materials with adequate strength and reinforcing to accommodate a 250lb passenger. Maximum riser height shall be 10" with a minimum tread depth of 8". Tread shall be a non-slip material applied either with a tape or in the painting process.
- 11. **Drive Shaft**: Shall have a drive shaft loop to prevent a broken shaft from touching the ground or contacting the brake lines.
- 12. <u>Engine</u>: Shall have the largest V-8 gasoline engine provided by the manufacturer with the maximum horsepower rating.
- 13. <u>Emergency Exits</u>: Shall be the necessary window exits provided to comply with FMVSS 217.
- 14. **Fast Idle**: Shall provide an engine fast idle control with both manual and automatic controls to increase engine idle RPM to a preset RPM when the transmission is in the PARK position and the parking brake is set. Idle RPM should automatically return to normal when the brake is released or transmission is put into gear.
- 15. **Floor**: Shall be exterior grade water-resistant plywood no less than 5/8" thick.
- 16. <u>Floor Covering</u>: Shall have a transit grade rubber with a minimum 1/8" thickness and shall be color keyed to the interior and seats subject to be approved by the purchaser.
- 17. <u>**Grab Rail**</u>: Shall also be installed to the ceiling of the vehicle (maximum distance from left side 12") to provide a passenger a secure holding area from front of vehicle to the rear.
- 18. <u>Heater</u>: Shall have the heaviest duty "after-market" auxiliary rear heating unit offered and achieve and maintain an interior temperature of 65 F. Shall also have a shutoff valve between the engine and rear heater to prevent coolant flow in the warmer months, a decal on body to show the valve location.
- 19. <u>Insulation</u>: Shall have fiberglass mats, high-density polystyrene or approved equal, and be used to insulate the entire body, sides, front, rear and roof, achieving a R-5 factor or greater.

- 20. <u>Interior Finish</u>: Shall be a <u>flame retardant fiberglass material or approved equal</u>, of sufficient thickness and durability to maintain it appearance under heavy usage, and be adequately supported to prevent buckling. Material shall be color keyed to the seat color and be subject to approval by the Department.
- 21. Keys: Two (2) keys minimum per vehicle.
- 22. License plate brackets: Front and rear.
- 23. <u>Lights, Interior</u>: Shall include a minimum of six (6) passenger ceiling mounted courtesy lights and one (1) driver courtesy light. Step well shall have at a minimum one (1) shielded light.
- 24. <u>Metal and Metal Fasteners</u>: All metal and metal fasteners, including any required nuts and washers, used in the manufacturing process shall be rust and corrosive resistant. Metal and metal coating processes to ensure rust and corrosive resistant properties shall be subject to testing and approval. Metal and metal screws exposed to the outside environment shall be stainless steel or approved equal to the extent possible.
- 25. <u>Mirrors</u>: Shall have **power** exterior mirrors with a "breakaway design" with a minimum of 54 square inches of reflective area with one on each side of vehicle and have added convex mirrors incorporated. Shall have an OEM day/night type rear view mirror and a convex rear view mirror center mounted above the windshield to provide driver full view of the bus interior.
- 26. <u>Paint</u>: Van shall be painted the manufacturer's standard white and have a 2" high intensity <u>white 3M Diamond</u> <u>Grade 983 Series reflective tape</u>, applied below windows on both sides of vehicle and below rear windows.
- 27. Radio: Shall provide an AM/FM/CD radio.
- 28. <u>Rear Axle</u>: Manufacturer to select axle ratio, which will provide the best overall performance, and of the heaviest duty available.
- 29. **<u>Running Board</u>**: Shall have heavy gauge diamond plate aluminum or approved equal running board on the driver side to allow ease of access to the cab area.
- 30. **<u>Rust proofing</u>**: Shall be the highest quality available and be applied to entire area of underbody including wheel wells.
- 31. Seats: Shall offer a standard fixed passenger seating in a combination of single and double transit seats permitting a center aisle. Seating shall be Freedman GO Seat ES or approved equal. Seats must meet or exceed all applicable Federal Motor Vehicle Safety Standards including FMVSS 207 and 210. Seating system must be tested in vehicle at an A2LA accredited lab to insure compliance to aforementioned standards. Double passenger seats must be minimum 35" wide, the cushion depth shall be 16" minimum and the cushion height above the floor shall be 17.5" minimum, 19.5" maximum. Back cushion height shall be "mid hi" and must be minimum 24" from the top of the seat cushion (not including the grab rail). Seat frame must be convertible to accept Child Restraint System (CRS-225) with LATCH hooks (Rigid & Recliner variations only). Child Restraint System (CRS-225) LATCH hooks must also be available as an option on foldaway seats. All ambulatory seats must be mechanically fastened to the base frame utilizing a U-bolt based system that allows for easy removal/installation (not applicable to flip or foldaway seats). All ambulatory seats shall utilize a UHSS (ultra high strength steel) leg. Seats must be designed to allow for the addition of accessories without being removed from the base frame. These accessories include grab rails and flip up US arm rests. Seat bottom covers are to be easily removable from the cushions without removing seats from the base frame. All covers shall use a plastic extruded "arrow in trench" system to fasten covers to the seating system and must not require the use of any specialized tools or equipment to replace or remove. All seat cushions must be attached to the seat frame through the use of the Lock-N-GO (or equivalent) system to allow for easy removal and replacement. Seats cushions shall also have the option of being mechanically fastened to the seat frame. All foam cushions must meet or exceed FMVSS 302. All foam cushions must be molded polyurethane to ensure maximum individual passenger comfort and durability. All exposed metal parts and surfaces must be chemically cleaned and powder coated black to provide a rugged, long lasting, rust and corrosion resistant finish. Fold-Away Seats: Seating shall meet the same requirements as ambulatory forward facing seats. The seat must be cantilevered and must not require an aisle leg or tether for support. The foldaway seat must require no more than 3 operations to either store or deploy. In the stored position, the foldaway seat must be less than 13" wide. All foldaway seats must match the visual and functional design of the other seats in the bus.
- 32. <u>Seat Belts</u> Seat frame must have a 3 point shoulder belt. All seats belts shall meet or exceed FMVSS 209 and 210. A premium web cutter shall be supplied with each vehicle and shall be mounted in a highly visible location in the driver's area and have a label stating "Seat Belt and Wheel Chair Securement Belt Cutter".

- 33. <u>Seating Capacity</u>: Item 1 shall have 12 passenger capacity plus driver (four fixed double seats and four fixed single seats plus factory single seat for driver), Item 2 shall have 8 passenger capacity plus driver with one wheelchair position (two fixed double seats, two fixed single seats and one double flip seat plus factory single seat for driver), Item 3 shall have 8 passenger capacity plus driver with two wheelchair positions (one double fixed seat, two single fixed seats, two double flip seats plus factory single seat for driver). <u>Seating diagrams depicting the manufacturer's offerings to meet the required specifications shall be submitted with each bid and shall include a weight analysis.</u>
- 34. <u>Suspension</u>: Shall be the highest GVWR offered by the manufacturer with **factory roll stability control** and a stabilizer bar shall be provided in the front. Rear suspension must accommodate any increased load capacity of an optional lift.

- 39. Wheelchair Restraint System: Item 2 shall have one wheelchair position and one restraint system and Item 3 shall have two wheelchair positions and two restraint systems. Belt restraint systems shall be a premium model complete wheelchair and occupant securement systems designed for endurance and ease of use. All wheel chair tie downs shall have self-tensioning retractors and the lap/shoulder belts shall have retractors. Securement system shall be flush mounted full width L-track kit or approved equal. A storage pouch for each set of restraints, designed to accommodate restraint belts, shall be constructed from commercial type heavy duty reinforced vinyl/cloth type material affixed to the inside of the vehicle in a location easily accessible and does not interfere with passenger comfort or seating placement. #### **B.** Options:

- A. <u>Backup Camera</u>: Shall offer a backup camera in place of the standard backup device that will have the camera mounted above the rear window, with a minimum 4 inch video screen mounted in the driver's area for ease of viewing but does not interfere with driver's view. Shall be a heavy duty system capable of enduring transit environment <u>and be either mounted in a recessed area or have a guard mounted to prevent damage to camera.</u>
- B. <u>Child Safety Alert System</u>: Shall offer a child safety alert system which requires the driver to perform an inspection of the passenger compartment before leaving the vehicle, **this shall be a Child Check-Mate System or an approved equal.**
- C. <u>Floor Covering</u>: Shall offer as an upgrade a transit grade Altro rubber with a minimum 1/8" thickness and shall be color keyed to the interior and seats.
- D. Seats: Shall offer as an option additional seats with the three-point Child Restraint System (CRS).

**Specification Detail:** <u>All bidders must provide the manufacturer's specifications in sufficient detail to determine</u> compliance with all specifications set-forth in the advertisement for bids for chassis, body and accessories. <u>The</u> bidder must provide floor plan drawings of the proposed vehicle-seating configuration and weight analysis.
