- 1. ACCEPTANCE AND REJECTION: The Arkansas State Highway and Transportation Department (AHTD) reserves the right to reject any or all bids, to accept bids in whole or in part (unless otherwise indicated by bidder), to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the State.
- 2. **PRICES:** Unless otherwise stated in the Bid Invitation, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified (feet, each, lbs., etc.), (3) prices must be F.O.B. destination specified in bid, (4) prices must be firm and not subject to escalation, (5) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit prices shall govern. Discounts from bid price will not be considered in making awards.
- BID BONDS AND PERFORMANCE BONDS: If required, a Bid Bond in the form of a cashier's check, certified check, or surety bond issued by a surety 3. company, in an amount stated in the Bid Invitation, must accompany bid. B. Unit specifications:

- 1. <u>General</u>: Pneumatic tired Four Wheel Drive Skid Steer Loader of unit design engineered from the ground up for frontend loading operation. Loader shall have a minimum rated operating load of 2,500 pounds. The rated operating load shall not exceed 50% of the tipping load rating per SAE J818. Tipping load rating shall be in accordance with SAE J732.
- Engine: Rear mounted, liquid cooled diesel with a minimum piston displacement of 3.0 liters developing no less than 70 net horsepower at rated RPM. - 4. <u>Transmission</u>: Hydrostatic with joystick controls for steering, speed and direction. Shall have a minimum of two (2) ranges providing infinite travel speeds up to no less than 10 mph.
- 5. <u>Brakes</u>: Operational braking shall be dynamic through the hydrostatic transmission. Parking/emergency brake shall be spring applied, hydraulically released.

The demonstration would be performed (free of any charge) by the bidder or an authorized representative at a mutually acceptable location. If requested, the bidder should be prepared to demonstrate the equipment within thirty (30) days after notification. Failure of the bidder to perform a satisfactory demonstration within the specified time may be grounds for rejection of the bid.
- 10. <u>Cooperative Purchasing</u>: Other tax-supported entities* in Arkansas (cities, counties, state agencies, school districts, etc.) may purchase from this Contract on an individual basis under the same specifications and conditions, and at the pricing set forth by each vendor, all at the discretion of each vendor in each case. Prices could be reduced by a vendor for minor alterations in conditions (changing order quantities, deleting options, etc.) as agreed by both parties, but could not be raised above the contract bid price except for any additional freight charges. Vendors would not be required to sell to any such entity under this contract, and those entities would not be obligated to purchase from the contract.

Each entity wishing to purchase from the contract must make contact directly with the appropriate vendor(s). The Highway Department shall remain "out of the loop" for such transactions: all contact, orders, invoices, payments, etc. regarding such transactions must take place exclusively between the tax-supported entity and the vendor. The Department shall be held harmless of any and all liability arising from such transactions.

* Tax-supported entities are defined as those receiving more than half of total funding from appropriated tax funds.

B. Unit specifications:

- 1. <u>General</u>: Pneumatic tired Four Wheel Drive Skid Steer Loader of unit design engineered from the ground up for frontend loading operation. Loader shall have a minimum rated operating load of 2,500 pounds. The rated operating load shall not exceed 50% of the tipping load rating per SAE J818. Tipping load rating shall be in accordance with SAE J732.
- Engine: Rear mounted, liquid cooled diesel with a minimum piston displacement of 3.0 liters developing no less than 70 net horsepower at rated RPM. Shall be equipped with electric starter, battery and alternator. Shall have approved dry type air cleaner, pre-cleaner, lube oil filter, fuel filter(s), muffler and fuel tank with a capacity for no less than eight (8) hours of operation. Cooling system shall have anti-freeze protection to -20° F, or lower.
- 3. <u>Instruments</u>: Shall be equipped with ammeter or charge indicator, tachometer, electric hour meter, fuel gauge and all other necessary gauges or indicators, including temperature and oil pressure.
- 4. <u>Transmission</u>: Hydrostatic with joystick controls for steering, speed and direction. Shall have a minimum of two (2) ranges providing infinite travel speeds up to no less than 10 mph.
- 5. <u>Brakes</u>: Operational braking shall be dynamic through the hydrostatic transmission. Parking/emergency brake shall be spring applied, hydraulically released.
- 6. <u>Tires</u>: No less than 12.00 x 16.5 12 ply, with R-4 equivalent tread.
- 7. <u>Hydraulic System</u>: Shall consist of reservoir with baffles, oil cooler, hydraulic pump with a minimum output of 30 gpm, control valve/s with a minimum of three (3) spools, necessary relief valves, lift and dump cylinders, auxiliary hydraulic lines (complete with quick couplers) mounted on loader arm for supplying hydraulic oil flow to attachments, and necessary filters with replaceable elements. Controls shall be convenient to operator.
- <u>Cab</u>: Fully enclosed pressurized cab with side screens meeting the requirements of SAE J1040 and SAE J1043 for Rollover Protective Structure and Falling Object Protective Structure. Cab shall be equipped with safety glass windshield and windows, air conditioning, heater-defroster unit, front windshield wiper with washer, inside rear view mirror, headliner, floor cover plates, floor mat, adjustable suspension seat equipped with arm rests, and seat belt per SAE J386.
- 9. <u>Safety Equipment</u>: Shall be equipped with an interlock control system which requires the operator to be seated with the seat belt fastened before loader lift or bucket cylinder hydraulic circuits will operate. A lift arm support device shall also be provided.
- 10. <u>Quick Change Attachment System (Bobcat[™] Compatible)</u>: Loader shall be equipped with an attachment system which will allow the loader bucket and other attachments to be quickly attached or removed. The quick change attachment system furnished must allow the Bobcat[™] attachments currently owned by AHTD to be used with the loader.
- 11. <u>Attachments</u>: The unit shall be complete with the following attachments.
 - A. <u>Bucket</u>: Material bucket with a minimum SAE rated heaped capacity of 13.5 cubic feet complete with bolt-on cutting edge. Bucket width shall be no less than the outside to outside measurement of the tires. Maximum dumping height with bucket at dump angle shall be no less than 92". Bucket reach forward shall be no less than 26" at maximum dumping height with bucket at dump angle. Bucket shall be designed for use with quick change attachment system specified above.
 - B. <u>Cold Planer w/Water Kit</u>: Hydraulically driven cold planer attachment to be used in lieu of bucket. Shall operate efficiently at a minimum hydraulic flow of 30 gpm and be designed and recommended for use with skid steer loader provided. Shall have a minimum cutting width of 24" and be capable of a maximum cutting depth of no less than 5". Cutting drum shall be equipped with a minimum of 120 carbide bits. Shall have a tilt range of no less than 8° and side shift capability of no less than 20". Controls for cutting depth, tilt, side shift and cutting drum drive shall be mounted

in cab. Unit shall have a minimum weight of 1,200 pounds and be designed for use with quick change attachment system specified above. Shall be complete with water sprinkler kit for dust control and include water tank and all water hoses, hydraulic hoses, quick couplers, valves, controls, etc. required for proper operation.

- C. <u>Fork Lift</u>: Fork lift attachment to be used in lieu of bucket. Forks shall be no less than 4" wide and 42" long, constructed from heat treated steel with bottom tapered to allow chisel tips to slide under palletless loads. Fork spread width shall be hydraulically controlled and have a maximum spread capability of no less than 38". Fork backrest to be constructed of steel and be no less than 38" high.
- 12. <u>Delivery Requirements</u>: Unit shall be delivered with the cold planer attachment specified above completely installed and ready for operation. Pins, couplers or any other items required for proper removal of the cold planer attachment and installation of the material bucket or fork lift shall be furnished.
- 13. <u>Weight</u>: Operating weight of machine ready for continuous operation with cab, bucket, tires specified above, and as specified in SAE J732, shall be no less than 7,700 pounds.
- 14. <u>Additional Equipment</u>: Shall be equipped with backup alarm, front and rear work lights, four way warning flashers and vandalism protection.
- 15. <u>Color</u>: Manufacturer's standard color is acceptable.
- 16. <u>Warranty</u>: Units purchased under this specification shall be warranted against defects in material and workmanship for a minimum period of twelve (12) months (365 days) from date unit is placed in operation by AHTD.
 - A. Warranty shall include all parts, labor and transportation costs to the location of equipment.
 - B. If equipment cannot be repaired on location, warranty shall include cost of transport to the facility where the repair work will be done.
 - C. It will be the responsibility of the successful bidder to insure that repairs are completed in a timely manner.
 - D. If any warranty literature submitted with the bid conflicts with AHTD warranty requirements, the conflict(s) shall be specifically noted, corrected and included with the bid or the conflict(s) will be considered an exception to warranty specifications and the bid rejected.
 - E. Recent prior failure to provide warranty-work, parts, replacement parts or service, in a timely manner, for equipment from the same manufacturer or dealer shall be grounds for the rejection of any submitted bid, or for the denial of any otherwise qualified low bidder, whether such failure is attributable to the manufacturer or the dealer of the equipment. For the purposes of this paragraph "timely manner" means a period of time not exceeding thirty (30) calendar days to provide requested warranty-work, parts, replacement parts, or service. For the purposes of this paragraph "manufacturer" means the original manufacturer of the equipment and its successor or successors, regardless of number, and whether acquired by sale, merger, or otherwise. For the purposes of this paragraph "replacement part" means a part redesigned by a manufacturer to correct a design or engineering defect and which replacement part is capable of providing dependable performance in normal operation conditions for its normal service life without failure. Such bid or bids may be rejected by the Department until such failure or failures have been remedied to the satisfaction of the Department and until such manufacturer or dealer is providing such warranty-work, parts, replacement parts, and service in a timely manner.
