- 1. ACCEPTANCE AND REJECTION: The Arkansas State Highway and Transportation Department (AHTD) reserves the right to reject any or all bids, to accept bids in whole or in part (unless otherwise indicated by bidder), to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the State.
- 2. PRICES: Unless otherwise stated in the Bid Invitation, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified (feet, each, lbs., etc.), (3) prices must be F.O.B. destination specified in bid, (4) prices must be firm and not subject to escalation, (5) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit prices shall govern. Discounts from bid price will not be considered in making awards.
- BID BONDS AND PERFORMANCE BONDS: If required, a Bid Bond in the form of a cashier's check, certified check, or surety bond issued by a surety 3 company, in an amount stated in the Bid Invitation, must accompany bid. A. <u>General Conditions</u>:

- <u>Current Model</u>: All vehicles shall meet the requirements of Arkansas State Highway and Transportation Department Specifications attached to and made a part of this bid. Vehicles furnished under this specification shall be the latest improved model in current production, as offered to commercial trade, built for the U.S. market, and shall be of quality workmanship and material. Vehicles manufactured for foreign markets will not be accepted. All equipment offered under this specification shall be new. Used, reconditioned, shopworn, demonstrator, prototype or discontinued models are not acceptable.
- 2. <u>Literature</u>: Manufacturers literature, verifying adherence of proposed unit to each line item addressed in this specification, shall be submitted with the bid. If any literature and/or specifications of items conflict with AHTD specifications, the conflict(s) shall be specifically noted, corrected and submitted with the bid.
- 3. Any deviations from specifications and requirements herein must be clearly pointed out by bidder. B. Cab and Chassis:

- 1. <u>GVWR</u>: No less than 8,800 pounds.
- 2. <u>Wheelbase</u>: Minimum of 157", maximum of 165".
- 3. <u>Engine</u>: Minimum piston displacement of 5.7 liters equipped with dry type air cleaner, maintenance free battery with a minimum rating of 600 cold cranking amps at 0° F, full flow oil filter and not less than 130 amp alternator.
- 4. <u>Cooling</u>: Heavy duty cooling system with anti-freeze protection to -20° F, or lower.
- 5. <u>Transmission</u>: Automatic, with a minimum of six (6) forward speeds. Shall include an auxiliary transmission oil cooler.
- 6. <u>Transfer Case</u>: Minimum of two (2) speed ranges.
- 7. <u>Steering</u>: Hydraulic actuated power steering as regularly offered by manufacturer.
- 8. <u>Front Axle</u>: Hypoid type with a ratio of 3.73 or 4.10 to 1. (Alternate ratio may be provided if approved by AHTD prior to delivery.) Shall be equipped with automatic or manual locking hubs, or axle disconnect system. Capacity of front axle and springs shall be as recommended by manufacturer for vehicle to meet or exceed GVWR specified above.
- 9. <u>Rear Axle</u>: Hypoid type, semi or full floating, with locking or limited slip differential and a ratio of 3.73 or 4.10 to 1. (Alternate ratio may be provided if approved by AHTD prior to delivery.) Capacity of rear axle and springs shall be as recommended by manufacturer for vehicle to meet or exceed GVWR specified above.
- 10. <u>Brakes</u>: Power front and rear disc with four wheel anti-lock. Mechanical parking brake as regularly furnished by manufacturer.
- 11. <u>Cab</u>: Four (4) Door Extended Type Cab complete with insulation and all standard interior trim, dual electric intermittent windshield wipers with washers, right and left sun visors, floor covering consisting of manufacturer's standard materials and colors for model and trim level provided, factory installed fresh air heater defroster unit, factory installed electronic AM/FM radio, key lock on front doors, inside rear view mirror and right and left side low mount exterior mirrors no less than 8.5" x 5".
- 12. <u>Seating</u>: Two (2) three (3) person seating capacity bench seats. Front seat to be cloth split bench style with fold-down center arm rest. Rear seat upholstery to consist of manufacturer's standard materials and colors for model and trim level provided. Seat belts shall be provided for all seating positions.
- 13. <u>Air Conditioning</u>: Shall be equipped with factory installed air conditioning and include tinted glass.
- 14. <u>Tilt Steering Column</u>: Factory installed.
- 15. <u>Speed Control</u>: Factory installed automatic speed control.
- 16. <u>Wheels</u>: Five (5) 17" diameter steel disc with no less than 6.5" rim section.
- 17. <u>Tires</u>: Five (5) <u>On/Off Road</u> or <u>All Terrain</u> tubeless radials no less than, LT245/70R17, E load range.
- 18. <u>Fuel Tank</u>: Minimum fuel capacity of 30 gallons. Fuel fill hose assembly furnished with fuel tank shall be a minimum of 36" in length to allow attachment to an aftermarket body.
- 19. <u>Lights</u>: Dual beam headlights, parking lights, self canceling directional turn signals with hazard flasher switch, back up lights and front side marker lights. Rear lights to consist of stop and tail lights in addition to directional signals.
- 20. Equipment: Chrome front bumper, front and rear shock absorbers, hub caps, jack and lug wrench.
- 21. Keys: Minimum of four (4) ignition/door keys per vehicle.
- 22. <u>Color</u>: Sherwin Williams F8W2030 Frost White Acrylic Enamel, or equal. Front bumper shall be chrome. Rear bumper, grill, mirrors, wheels and hubcaps as regularly furnished by manufacturer.

C. Service Body:

- 1. <u>Body</u>: Low profile service body normally designed to mount on chassis described above.
- 2. <u>Construction</u>: Electrically welded all steel construction with edges rolled or folded. Body shall have longitudinal members and cross members welded for floor support. Body floor shall be constructed of no less than 12 gauge safety tread plate.

- 3. <u>Dimensions</u>:
 - A. <u>Body Length</u>: 96" 98".
 - B. <u>Body Width</u>: 76" 80".
 - C. <u>Body Height</u>: 35" 39".
 - D. <u>Body Floor To Compartment Top</u>: 19" 24".
 - E. Compartment Depth: 14" 15".
 - F. <u>Floor Width</u>: 48" 51".
- 4. <u>Compartments</u>: Each side of the body shall have a minimum of one (1) vertical compartment in front of the rear wheels, one (1) horizontal compartment over the rear wheels and a minimum of one (1) vertical compartment behind the rear wheels. Vertical compartments shall be full height and have adjustable shelves. Each horizontal compartment shall have an adjustable shelf and dividers. All doors shall be protected from weather and have double panels with flush type handles and locks keyed alike. Doors shall have rubber seals to keep out water and dust.
- 5. <u>Tailgate</u>: Body shall have a hinged tailgate no less than 9" high that opens to floor level with chain or arm support.
- 6. <u>Bumper</u>: Shall have a rear step plate type heavy duty bumper with recess and ball hitch plate. Bumper brackets shall mount to truck frame.
- 7. <u>Lights</u>: Combination tail and directional lights and backup lights to meet ICC regulations.
- 8. Color: Body shall be painted Sherwin Williams F8W2030 Frost White Acrylic Enamel, or equal.

D. <u>Warranty</u>:

- 1. Cab & chassis purchased under this specification shall include manufacturer's standard warranty.
- 2. Body purchased under this specification shall be warranted against defects in material and workmanship for a minimum period of twelve (12) months (365 days) from date unit is placed in operation by AHTD.
- 3. Warranty shall include all parts and labor cost associated with needed repairs based on defects in material and workmanship.
- 4. It will be the responsibility of the successful bidder to insure that repairs are completed in a timely manner.
- 5. If any warranty literature submitted with the bid conflicts with AHTD warranty requirements, the conflict(s) shall be specifically noted, corrected and included with the bid or the conflict(s) will be considered an exception to warranty specifications and the bid rejected.
- 6. Recent prior failure to provide warranty-work, parts, replacement parts or service, in a timely manner, for equipment from the same manufacturer or dealer shall be grounds for the rejection of any submitted bid, or for the denial of any otherwise qualified low bidder, whether such failure is attributable to the manufacturer or the dealer of the equipment. For the purposes of this paragraph "timely manner" means a period of time not exceeding thirty (30) calendar days to provide requested warranty-work, parts, replacement parts, or service. For the purposes of this paragraph "manufacturer" means the original manufacturer of the equipment and its successor or successors, regardless of number, and whether acquired by sale, merger, or otherwise. For the purposes of this paragraph "replacement part" means a part redesigned by a manufacturer to correct a design or engineering defect and which replacement part is capable of providing dependable performance in normal operation conditions for its normal service life without failure. Such bid or bids may be rejected by the Department until such failure or failures have been remedied to the satisfaction of the Department and until such manufacturer or dealer is providing such warranty-work, parts, replacement parts, and service in a timely manner.
