- ACCEPTANCE AND REJECTION: ARDOT reserves the right to reject any or all bids, to accept bids in whole or in part (unless otherwise indicated by bidder), to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the State.
- 3. **PRICES:** Unless otherwise stated in the Bid Invitation, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified (feet, each, lbs., etc.), (3) prices must be F.O.B. destination specified in bid, (4) prices must be firm and not subject to escalation, (5) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit prices shall govern. Discounts from bid price will not be considered in making awards.

PURPOSE OF SPECIFICATIONS

This item shall be a vehicle suitable for public transportation. The intent for these specifications is to set-forth the minimum performance for a commercial conversion van. The vehicle shall be a conversion of a standard production van, which will be used to transport elderly and ambulatory disabled persons living in urban and rural areas. Vehicle shall be available as a fixed seat passenger vehicle. This vehicle shall accommodate various seating combinations and will be required to operate on all types of neighborhood streets and rural roads with frequent starts and stops.

- 9. <u>Raised Roof</u>: Shall offer an OEM raised medium roof. Roof shall be factory installed by the OEM not a roof modified by the conversion center. Shall install a placard in a location clearly visible to the driver stating the appropriate height restriction of the raised roof dome cap.
- 10. **Door Locks:** Shall have power door locks on all entry doors.
- 11. Door, Ambulatory Front Entrance: Shall have the standard sliding side door.
- 12. <u>Drive Shaft</u>: Shall have a drive shaft loop(s) to prevent a broken shaft from touching the ground or contacting the brake lines.

Metal and metal coating processes to ensure rust and corrosive resistant properties shall be subject to testing and approval. Metal and metal screws exposed to the outside environment shall be stainless steel or approved equal to the extent possible.

- 25. <u>Mirrors</u>: Factory installed power dual outside breakaway 6" X 9" mirrors. Shall have an OEM day night type rear view mirror and a maximum 4" X 7" convex rear view mirror center mounted to provide driver full view of the van's interior.

- J. **<u>CNG/LPG Prep Package</u>**: Shall offer a CNG/LPG prep package on the standard gasoline engine.
- K. <u>Fold-Up Two Passenger Seat Deletion</u>: Shall offer a price reduction for deleting the fold-up twopassenger seats in the ADA equipped unit.
- L. <u>Single Fixed Seat Deletion</u>: Shall offer a price reduction for deleting the single fixed seats in the ADA equipped unit.

Signatures: <u>All bidders must complete the Bid Quotation Form by providing all required.</u> <u>Each page of the</u> <u>Appendix A and B must be initialed and returned with the bid quotation.</u> <u>The Required Federal Certifications and</u> <u>Contractual Provisions (Appendix B) must be executed by completing and signing the last page in ink and be</u> <u>attested by a Notary Public.</u>

Specification Detail: <u>All bidders must provide the manufacturer's specifications in sufficient detail to determine</u> <u>compliance with all specifications set-forth in the advertisement for bids for chassis, body and accessories.</u> <u>The bidder must provide floor plan drawings of the proposed vehicle-seating configuration and weight analysis.</u>

Warranty and Service Center: <u>All bidders must have, and identify, a warranty and service location in</u> <u>Arkansas</u> and staffed with factory trained personnel for all vehicles and major component equipment proposed. Further, the bidder must be able to perform, or have performed warranty and service on all items not covered by original equipment manufacturer's warranty. Federal Register Standard: Any equipment furnished on a vehicle purchased under this specification for which "Federal Register Standard" has been established at time of delivery shall comply with the requirements of applicable standard and all equipment required by said standard shall be furnished whether or not it is specifically mentioned in this specification.

Operator's Manual: The successful bidder shall furnish copy of Operator's Manual published by vehicle manufacturer with each vehicle delivered.

Advertisements: No dealer advertisement shall be affixed to the vehicle.

Serviced: Each vehicle shall be completely serviced, cleaned and thoroughly inspected (in accordance with manufacturer's required or recommended pre-delivery service) just prior to delivery to the Department.

Vehicle OEM Warranty - The successful bidder shall not allow any contractors/manufacturers to perform any manufacturing process, component installation, or take any other action which will violate or otherwise cause the vehicle OEM to withdraw their full and complete warranty.

Warranties: The successful bidder shall furnish all warranty data for each vehicle delivered, as well as any warranty data for non-OEM components installed. Certification Tag: The dealer or manufacturer shall affix a certification tag inside the vehicle that states the actual passenger design capacity including the driver.

The Department shall adhere to the following:

The decision of the Department's Chief Legal Counsel shall be binding upon the Bidder and the Bidder shall abide by the decision. <u>Performance During Dispute</u> - Unless otherwise directed by the Department, the Bidder shall continue performance under any bid award while matter in dispute is being resolved. <u>Claims for Damages</u> - Should either party to the bid award suffer injury or damage to person or property because of any act or omission of the party of any of his employees, agents or other for whose acts he is legally liable, a claim for damages therefore shall be made in writing to such other party within a reasonable time after the first observance of such injury or damage. <u>Remedies</u> - Unless provided otherwise, all claims, counterclaims, disputes and other matters in question between the Department and the Bidder arising out of or relating to this agreement or its breach will be decided by arbitration if the parties mutually agree.
