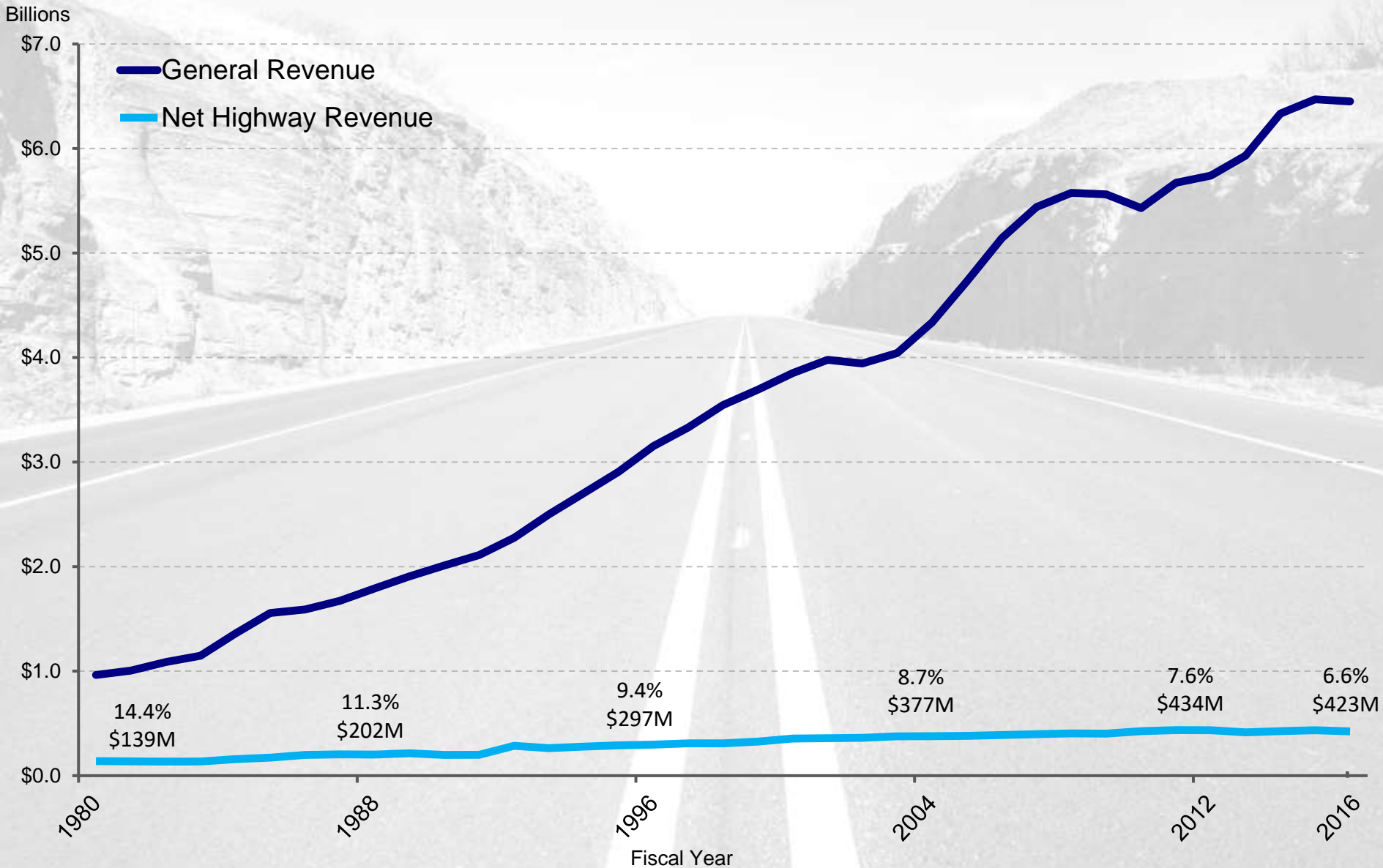

# Percent of Highway vs. General Revenue



Excludes County & City Aid funds | Excludes CAP funds

## THEN

In 1998, **200 lane miles** of highway could be overlaid with \$10 million.

## NOW

In 2018, **90 lane miles** of highway could be overlaid with \$10 million.

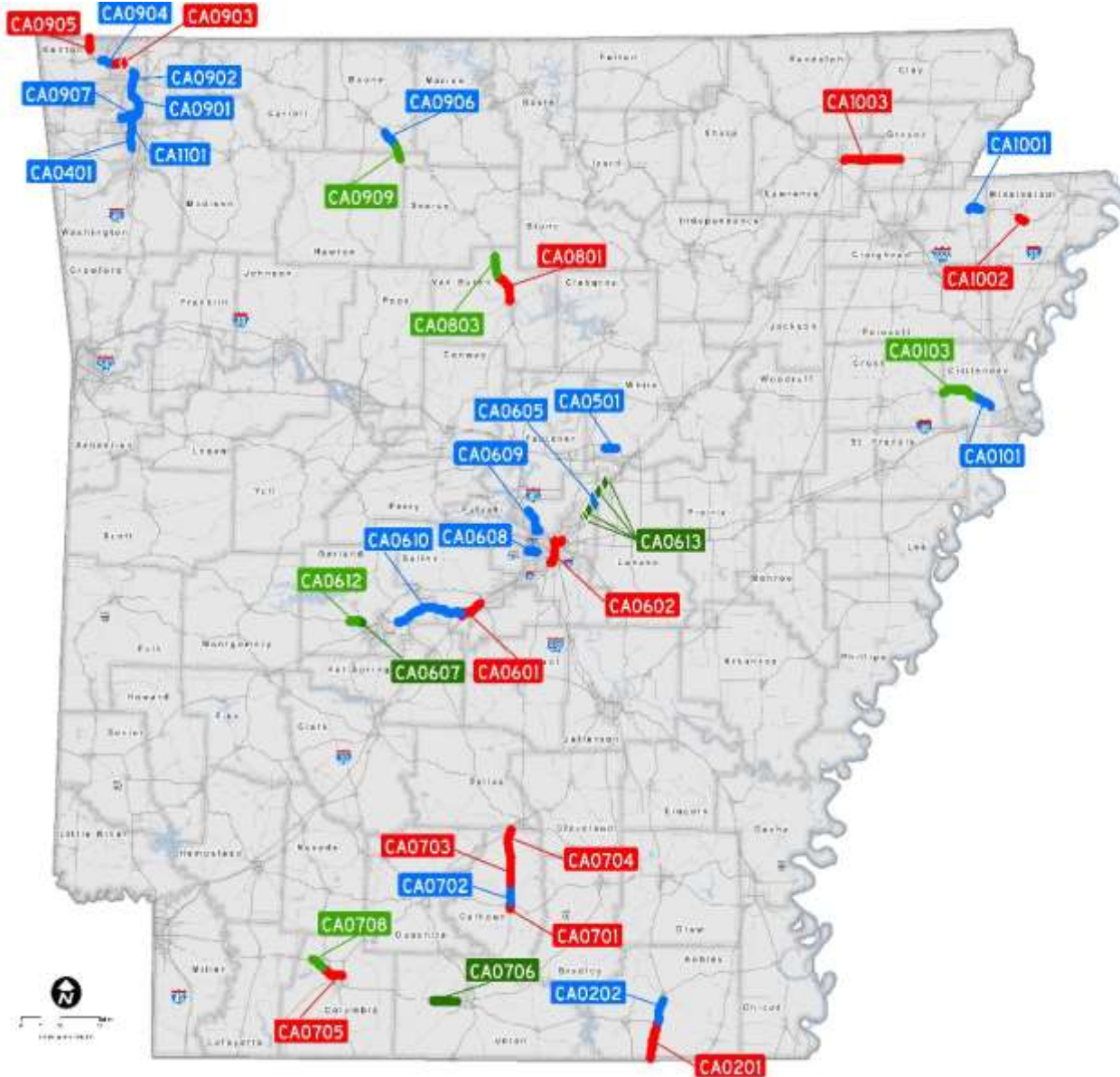


# Current Connecting Arkansas Program

- Provides Temporary Half-Cent Sales Tax
- ARDOT Revenue Dedicated to CAP Projects
- County and City Revenue for Local Roads & Streets
- Expires June 2023

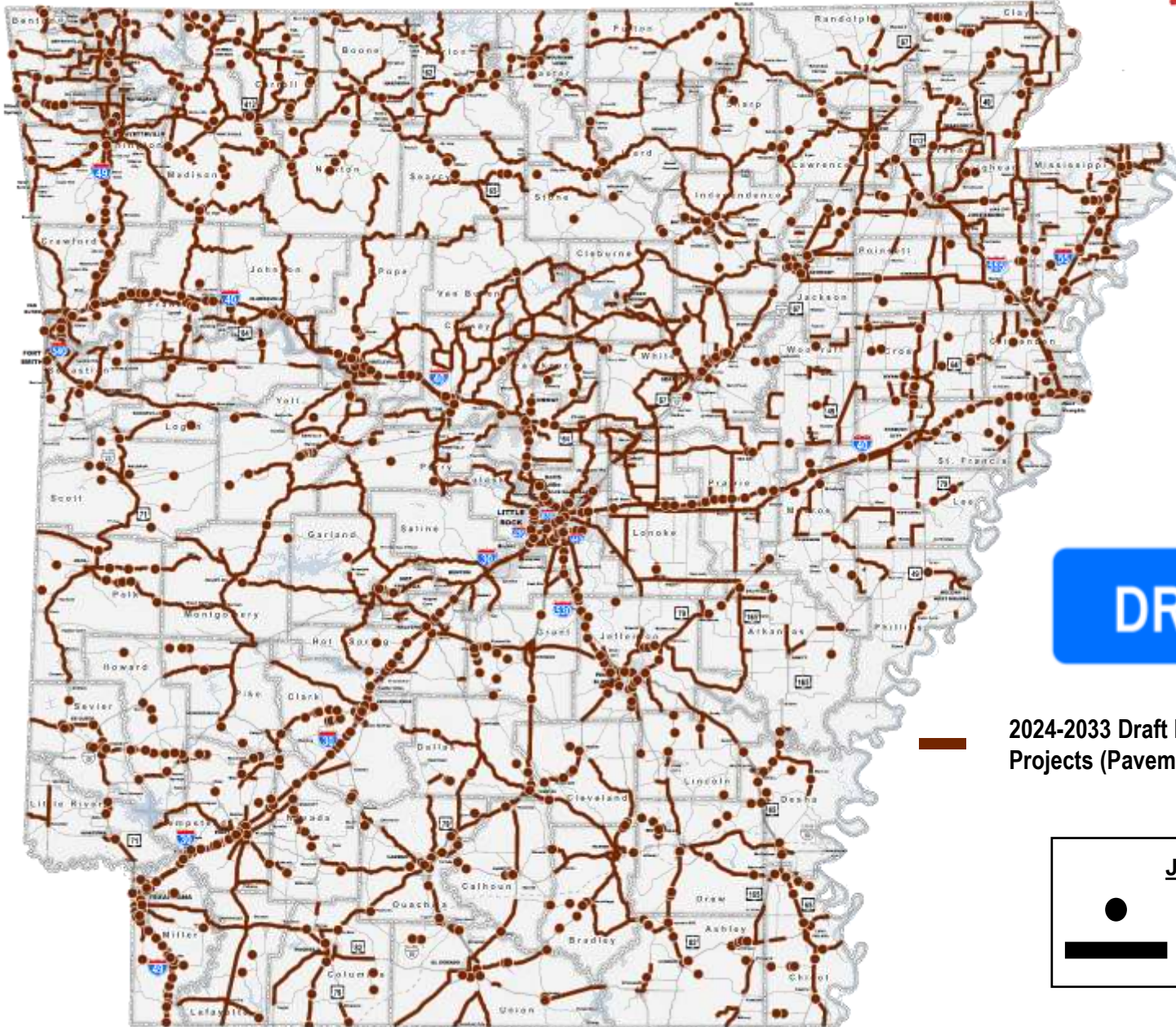
# If Issue 1 Passes



## 10-Year *Renew Arkansas Highways* Program

Pavement Preservation	\$3.0 Billion
Bridge Improvements and Preservation	\$1.1 Billion
Interstate Maintenance	\$1.0 Billion
Capital and Congestion Relief (CAP-2)	\$1.8 Billion
Safety Improvements	\$0.5 Billion
<b>Total</b>	<b>\$7.4 Billion</b>





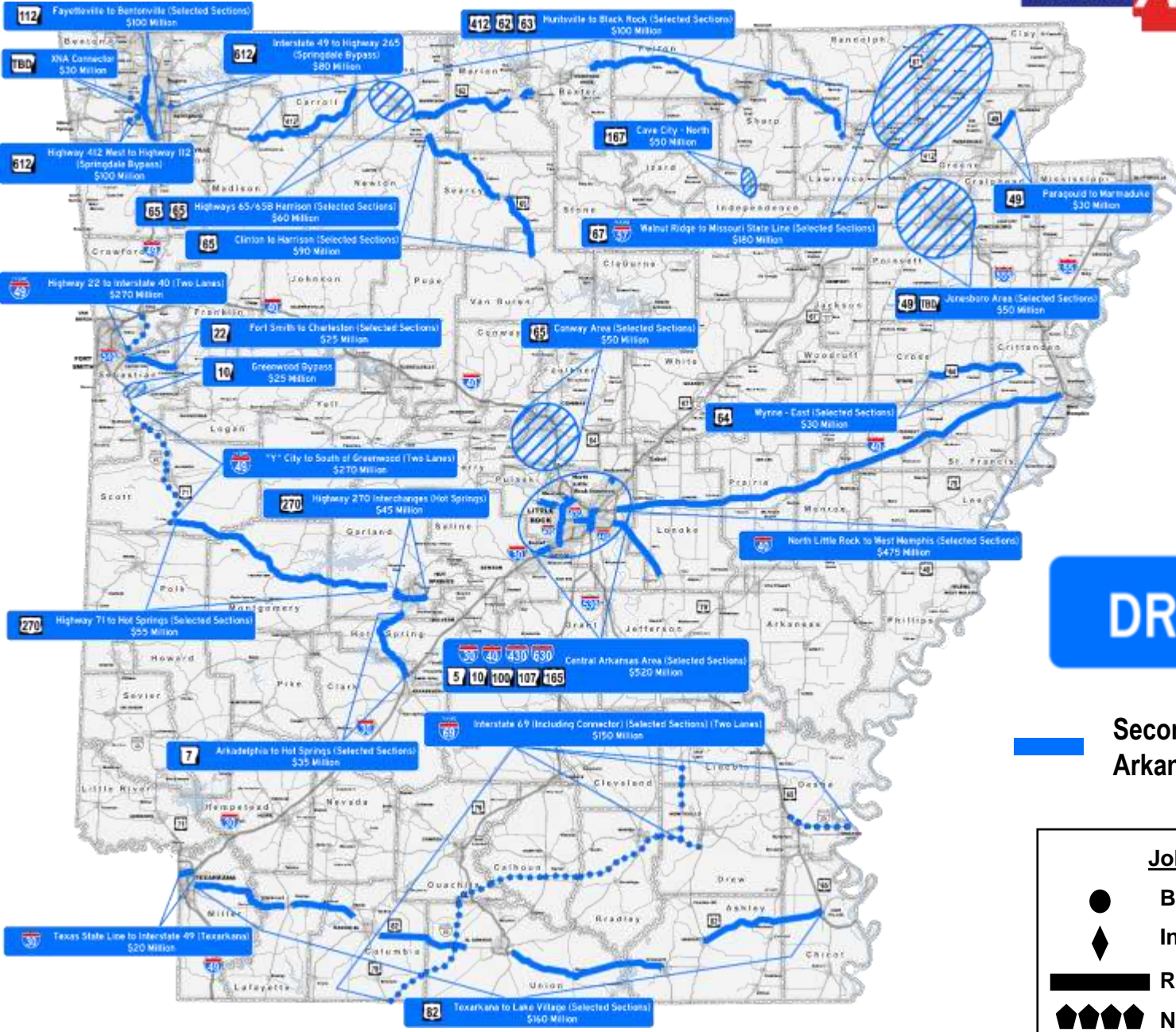

# If Issue 1 Fails

## State Highways

2023 - \$740 Million

2024 - \$535 Million

## City Streets

2023 - \$150 Million

2024 - \$106 Million



## County Roads

2023 - \$150 Million

2024 - \$106 Million

**30% Reduction**

# If Issue 1 Fails

## Cross County

2023 – \$1.4 Million

2024 – \$1.0 Million

**Loss of Funding – \$400,000 Per Year**

## City of Wynne

2023 – \$0.7 Million

2024 – \$0.5 Million

**Loss of Funding – \$200,000 Per Year**

ARDOT – Educate Voters  
Roads and Bridges Coalition – Campaign

- The cost of the current 1/2 cent sales tax for the average family with a median income is about **\$8/month**
- If Issue 1 passes, the cost to the taxpayers will remain the same as it is now.
  - No Increase
  - No Decrease
- This tax does not apply to groceries and it can only be used for road improvements.
