Environmental Documentation for State Funded Projects

The purpose of this project is to clean and paint the Harrisburg Road bridge (Hwy. 1B) crossing over Interstate 555 (Structure #06279) in the city limits of Jonesboro, Arkansas. A project location map is attached.

The existing bridge sustained severe damage caused by a tractor-trailer collision with the eastern column of the northern bent on June 27, 2017. The ensuing fire bent steel supports, crumbled concrete columns, required additional concrete excavations, and soot damaged the existing steel structures.

The proposed painting project will clean and repaint the existing steel structure to its original color and paint thickness. The existing paint system consists of zinc chromate primer with an aluminum topcoat, which will require containment and proper disposal methods. An EPA ID number will be necessary to properly transport, store, and dispose of hazardous waste generated from the site.


After appropriate environmental review it has been determined that, the subject job will not affect any wetlands, cultural resources, or endangered species. Field inspections found no evidence of existing underground storage tanks. No public involvement will be required for the project.

This job proposes to clean and paint AHTD Bridge #06279 on Highway 1B, over Interstate 555, in Jonesboro, Craighead County. A records check at the Arkansas Archeological Survey shows no sites near the bridge. No cultural indicators were found on the 1849 General Land Office map near the bridge. The 1936 Craighead County road map shows no structures near the bridge. No recorded historic structures are shown on the AHPP structure database near the project. The bridge was built in 1989 and therefore is not eligible for the National Register of Historic Places. The project will require no new ROW. All work will be within the existing ROW and the extremely limited scope of the project does not have the potential to affect any undisturbed land surfaces or potential historic properties. This project is subject to the 1999 MOA and falls under the exempted Work Category "Minor Bridge Work." The project is not considered an undertaking and requires no further work or Section 106 review.
