Tier 1 Categorical Exclusion

After appropriate environmental review, it has been determined that the subject job is a Tier 1 Categorical Exclusion as described by the AHTD/FHWA Memorandum of Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for this project.

This project consists of low-cost countermeasures consisting of: high friction surface treatment, shoulder mumble stripes, centerline rumble strips, pavement markings, various signage, ultra-thin bonded wearing course, and guardrail extension and/or replacement at various locations. All work will occur within the existing right of way. The countermeasure locations are shown on the attached map.

No Section 404 Permit will be required. The project is subject to the 1999 Memorandum of Agreement and falls under the exempted Work Category "Safety/Traffic Operation. This project in not considered an undertaking and requires no further work or Section 106 review.


