The Environmental Division has reviewed the referenced project and it falls within the definition of a Tier 2 Categorical Exclusion under 23 Code of Federal Regulations, Section 771.117, and the ARDOT/FHWA Memorandum of Agreement on the processing of Categorical Exclusions. A public hearing will not be offered for this project.

The purpose of this project is to replace two bridges over De Roche Creek on Interstate 30 in Clark and Hot Spring Counties. Total length of the project is 0.17 mile. The attached figure illustrates the project location.

Existing Interstate 30 consists of four 12-foot wide travel lanes with 6-foot wide inside shoulders (4-foot paved) and 10-foot wide outside shoulders. The existing bridges (3853 A&B) have 38.4' x 212' steel simple span superstructures supported by concrete intermediate bents on spread footings with end bents on H-pilings. The existing right of way width is 400 feet.

Proposed improvements include two replacement bridges with 40' x 170' concrete decks with steel plate girders. The approaches will consist of four 12-foot wide paved travel lanes with 6-foot wide inside shoulders (4-foot paved) and 10-foot wide outside shoulders. No new right of way will be acquired for this project.

There are no relocations, endangered species, prime farmland or environmental justice issues associated with this project. No impacts to cultural resources is anticipated; concurrence from the State Historic Preservation Officer was cleared under the original job (070460) and is attached. Field inspections found no evidence of existing underground storage tanks or hazardous waste deposits.

Based upon the ARDOT's Policy on Highway Traffic Noise Abatement, a noise analysis is not required for this project. This project does not involve added capacity, construction of new through lanes or auxiliary lanes, changes in the horizontal or vertical alignment of the roadway, or exposure of noise sensitive land uses to a new or existing highway noise source.

The official species list obtained through the US Fish and Wildlife Service's (USFWS) Information for Planning and Consultation (IPaC) website lists Piping Plover (*Chardarius melodus*), Arkansas Fatmucket (*Lampsilis powellii*), Ouachita Rock Pocketbook (*Arcidens wheeleri*), Pink Mucket (*Lampsilis abrupta*), Rabbitsfoot (*Theliderma cylindrica*), Spectaclecase (*Margaritifera monodonta*), American burying beetle (*Nicrophorus americanus*), and Missouri bladderpod (*Physaria filiformis*) as species potentially affected by the proposed project. This project will not affect these species due to the limited scope of the action (work within existing right of way), lack of suitable habitat, and distance to known species locations. IPaC also lists northern long-eared bat (*Myotis septentrionalis*) as possibly affected. This project may affect northern long-eared bat, but any incidental take is not prohibited due to the final 4(d) rule.

The project will have a discharge of dredged or fill material into waters of the United States associated with the culverts for the temporary work road, therefore a Section 404 permit will be required. The project should be authorized by Nationwide Permit 14 for Linear Transportation Projects as defined in Federal Register 82(4): 1860-2008.

Clark and Hot Spring Counties participate in the National Flood Insurance Program. The project lies within the Zone A, Special Flood Hazard Area. The final project design will be reviewed to confirm that the design is adequate and that the potential risk to life and property are minimized. Adjacent properties should not be impacted nor have a greater flood risk than existed before construction of the project. None of the encroachments will constitute a significant floodplain encroachment or a significant risk to property or life.



The species list fulfills the requirements of the U.S. Fish and Wildlife Service (Service) under section 7(c) of the Endangered Species Act (Act) of 1973, as amended (16 U.S.C. 1531 *et seq.*). 
