- SUBJECT: Job Number 090519 FAP Number STPF-0005(46) Hwy. 65 & Hwy. 62 Signal (Boone Co.) (S) Route 65, Section 2 & Route 62, Section 7 Boone County Tier 1 Categorical Exclusion

The purpose of this project is to install a traffic signal at the intersection of Highway 62 and Highway 65 in Boone County. A concrete driveway will be removed directly across from the intersection. A public hearing will not be offered.

The subject job is covered under the Memorandum of Agreement with the State Historic Preservation Officer executed on June 21, 1999. The job consists of conducting work within a previously disturbed area. All work will be within the existing right of way and does not have the potential to disturb cultural resources.

The official species list obtained through the US Fish and Wildlife Service's (USFWS) Information for Planning and Consultation (IPaC) website identifies the gray bat (*Myotis grisescens*), the Indiana bat (*Myotis sodalis*), the northern long-eared bat (*Myotis septentrionalis*), and the Ozark big-eared bat (*Corynorhinus townsendii ingens*) as potentially occurring within the proposed project area. A "no effect" determination was made for the federally listed bat species, due to the limited scope of the project, and lack of suitable habitat.

There are no relocations, environmental justice issues, prime farmland, or wetland/stream impacts associated with this job. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria


pollutants and has not been linked with any special mobile source air toxic (MSAT) concerns.

SUBJECT: Cultural Resources Clearance Job Number 090519 Hwy 65 & Hwy. 62 Signal (Boone Co.) (S) Route 65, Section 2 Route 62, Section 7 Boone County

The Arkansas Department of Transportation (ARDOT) proposes to install a roadway signal at the intersections of Highway 62 and 65 in Boone County. Current project plans indicate that all activity will be confined to the existing right-of-way (ROW). No new ROW will be acquired as a result of this project.

An examination of the Arkansas Archeological Survey's (AAS) and the Department of Arkansas Heritage's Arkansas Historic Preservation Program (AHPP) records was conducted for previously recorded archeological sites and National Register of Historic Places (NRHP) properties located near the project area. According to these records, no previously recorded archeological sites or historic properties are located within the vicinity of the project area.

The proposed road construction will occur in previously disturbed areas inside the current ROW. As such, this activity does not have the potential to affect any undisturbed land surfaces or potential cultural resources. Therefore, this project is subject to the 1999 MOA and falls under the exempted category "Safety Improvements." This project is requires no further work or Section 106 Review.
