SUBJECT: Job Number A20009 Hwy. 82 – Hwy. 65 (S) Route 160, Sections 11 & 12 Ashley & Chicot Counties Environmental Documentation for State Funded Projects

The purpose of this project is to preserve and rehabilitate 22.7 miles of Highway 160 between Highway 82 and Highway 65 in Ashley and Chicot Counties. Rehabilitation work will include a level and chip seal of the roadway along with a level and overlay through the town of Portland. All work will take place within existing right of way. A project location map is attached.


The project will not involve relocations, wetlands, wellhead protection areas/public water supplies, underground storage tanks, hazardous materials, environmental justice issues, or cultural resources. The project is exempt from Section 7 of the Endangered Species Act and a noise analysis as there is no federal nexus for this project. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxic concerns. The Cultural Resources clearance is attached.

The project will not have a discharge of dredged or fill material into the waters of the United States; therefore, a Section 404 permit will not be required.

This State-Aid job proposes to overlay 22.704 miles of Hwy. 160 between Hwy. 82 and Hwy. 65, in Ashley and Chicot Counties. Since there are no Federal funds or permits used on this project, Section 106 review is not required.
