SUBJECT: Job Number 080579 FAP Number NHPP-40-3(138) Atkins – Plumerville (S) Route I-40, Section 22 & 31 Conway & Pope Counties Tier 1 Categorical Exclusion

The purpose of this project is to preserve and rehabilitate 19.3 miles of Interstate 40 between Atkins and Plumerville. The project will include mill and overlay of the main lanes and frontage roads, along with guardrail and barrier wall upgrades. No repair or preservation work to the bridges is currently planned. All work will take place within existing right of way. A project location map is attached.

The project will not involve relocations, endangered species, prime farmlands, wetlands, underground storage tanks, hazardous materials, any environmental justice issues, or cultural resources. This project has been determined to generate minimal air quality impacts for Clean Air Act criteria pollutants and has not been linked with any special mobile source air toxic concerns. The Cultural Resources clearance is attached.


The project will not have a discharge of dredged or fill material into waters of the United States; therefore, a Section 404 permit will not be required.

After appropriate environmental review, it has been determined that the subject job is a Tier 1 Categorical Exclusion as described by the ARDOT/FHWA Programmatic Agreement on Categorical Exclusion Documentation and Processing. A public hearing will not be offered for this project.

SUBJECT: Updated Cultural Resources Clearance Job Number 080579 Atkins – Plumerville (S) Route I-40, Sections 22 & 31 Conway and Pope Counties

This job proposes to conduct pavement preservation on an existing 19.3 miles of road surface on Interstate 40 from Exit 94 East of Atkins in Pope County to past the Exit 112 east of Plumerville in Conway County. A records check of the Arkansas Archeological Survey and Arkansas Historic Preservation Program's databases shows no sites or structures in or near the right-of-way (ROW). No cultural indicators were found on the 1939,1840, and 1955 General Land Office plat maps in or near the project. The 1936 Conway and Pope County road maps show several structures along the route. Ten bridges (X0152, X0134, X0135, X0136, A3997, B3997, A5032, B5032, A5033, and B5033) will be included within this project area.

The ten bridges were built between 1967 and 1969; however, they were not evaluated for eligibility to the National Register of Historic Places due to the Advisory Council on Historic Preservation's Section 106 exemption regarding effects to the Interstate Highway System (filed on the Federal Register as 69 FR 77979-77981 and authority of 16 U.S.C. 470v; 36 CFR 800.14(c) on March 7, 2005).

The project will require no new ROW. All work will be within the existing ROW and the extremely limited scope of the project does not have the potential to affect any undisturbed land surfaces or potential historic properties. This project is subject to the 1999 MOA and falls under the exempted Work Category "Resurfacing." The project is not considered an undertaking and requires no further work or Section 106 review.
