The ARDOT Environmental Division reviewed the referenced project and, in consultation with the FHWA, determined that this action falls within the definition of a Categorical Exclusion as described by CFR 771.117(a) and (d)(13). The following information is included for your review and, if acceptable, approval as the environmental documentation for this project.

The purpose of this project is to improve capacity and safety for a portion of Highway 7 from Highway 7 Spur to Highway 5 in Garland The proposed project will include overlay section, County. an to be widened, the construction of a roundabout section and the Highway 5/7 intersection. The total project length is approximately A project location map is enclosed. The existing roadway 4.3 miles. consists of two 11-foot wide paved travel lanes with 4-foot wide paved shoulders. Existing right of way width averages 60 feet.

Proposed improvements include a 0.47-mile long overlay section at the southern end of the project. The remainder of the project will consist of three 12-foot wide paved travel lanes with 4-foot wide bike lanes, concrete curb and gutter, 3-foot wide grass berms, and 5-foot wide Job Number 061547 Tier 3 Categorical Exclusion Page 2 of 5

sidewalks on both sides of the highway. The roundabout at the Highway 5/7 intersection will have a single 20-foot wide lane. The proposed right of way width will average 120 feet. Approximately 27.3 acres of additional right of way will be required for this project. Of this acreage, 4.3 acres are prime farmland. Form NRCS-CPA-106 is enclosed.

Two residential tenants, four businesses, and three landlord businesses will be relocated as a result of this project. Of these, one residential tenant, two businesses, and two landlord businesses will be relocated due to the roundabout construction. Public Law 91-646, Uniform Relocation Assistance Act of 1970, as amended, will apply. A Conceptual Stage Relocation Study is enclosed. Each resident and business that will be relocated had the opportunity to discuss the relocation process with ARDOT staff at the Public Involvement Meeting or through a personal visit. All concerns and/or issues were resolved to the satisfaction of the property owners and tenants.

The following information was utilized to determine if a disproportionate impact would occur to minority and/or low income households:

- Conducting field observations of the populations in the project area, and holding a public involvement meeting.
- Utilizing census data gathered from the Environmental Justice Screening and Mapping Tool along with the American Factfinder. This information shows that the Latino population in the census tracts containing the project area is approximately 3%, while the Low-Income population is approximately 21.6%. The percentages of these populations in Garland County and Hot Springs are 5.3 and 8.1 % Latino; and 20.6 and 27.9 % Low-Income, respectively.
- A Conceptual Stage Relocation Inventory Study to determine if replacement housing and businesses were available.

Although relocations were minimized as much as possible during design, one tenant household to be relocated is considered to be low income and another is minority (Latino) and low income. The tenants were informed of the project and are aware of their eligibility for relocation assistance. The Conceptual Stage Relocation Study showed that available comparable dwellings are in the project area that are within the financial means of those being relocated. Special relocation advisory services and assistance will be provided commensurate with the needs of these tenants.

The proposed improvements would not result in any permanent disconnection or division of any community or neighborhood areas, and would not eliminate the community service facilities currently existing in the project area. Although minority and low-income populations are affected by the project, a determination has been made that the proposed project will not have a disproportionate impact on the Environmental Justice and Title VI populations.

Two underground storage tanks (USTs) at Station 260+30 right may be impacted and the extent of any impacts will be determined during the right of way acquisition process. The proposed Highway 5/7 roundabout will impact three USTs at Station 329+00 left, two 10,000 gallon above ground storage tanks (ASTs) at Station 326+40 left and four USTs at Station 324+50 right. The property at Station 324+50 right is known to have oil contamination and is being acquired to provide control of access for this project and for a future full interchange proposed as part of Job R60016. Further evaluation of the property will be conducted once the interchange design is available. All USTs and the ASTs will be removed in accordance with Arkansas Department of Environmental Quality removal regulations.

Several unnamed ephemeral and intermittent streams will be relocated to accommodate the widening of Highway 7, resulting in approximately 3,000 linear feet of stream impacts. Stream impacts are expected to tributaries to the South Fork of the Saline River. The South Fork of the Saline River is ecologically sensitive waterbody and will considered an require Individual Water Quality Certification prior to construction. Construction of the proposed project should be allowed under the terms of a Section 404 provided Standard Permit. Compensatory stream mitigation will be ARDOT's Upper Saline Mitigation Bank in Saline County. No wetlands will be impacted.

The official species list obtained through the U.S. Fish and Wildlife Service's (USFWS) Information for Planning and Consultation website identified the following federally listed species as having the potential to occur within the proposed project vicinity: northern long-eared bat (*Myotis septentrionalis*), Pink Mucket (*Lampsilis abrupta*), Rabbitsfoot (*Theliderma cylindrica*), Arkansas Fatmucket (*Lampsilis powellii*), harperella (*Ptilimnium nodosum*) and Missouri bladderpod (*Physaria filiformis*).

The Final 4(d) Rule and Programmatic Biological Opinion applies to the project's activities that have the potential to affect northern long-eared bats. The Final 4(d) Rule exempts the incidental take of northern long-eared bats from take prohibitions in the Endangered Species Act. The exemptions apply as long as the activities do not occur within 0.25 mile of a known hibernaculum or within 150 feet of a known occupied maternity roost from June 1 to July 31. No known hibernacula or maternity roosts exist within the project limits; however, a winter clearing restriction will be included in the job contract that prohibits tree clearing between April 1 and November 15.

A 'no effect' determination was made for the federally listed mussel and plant species due to the lack of habitat in the project area. The USFWS concurred on April 2, 2018. The official species list, 4(d) Rule Streamlined Checklist, and USFWS concurrence letter are enclosed.

Garland County participates in the National Flood Insurance Program. The project lies within Zones A and AE, Special Flood Hazard Areas. The final project design will be reviewed to confirm that the design is adequate and that the potential risk to life and property are minimized. Adjacent properties should not be impacted nor have a greater flood risk than existed before construction of the project. None of the encroachments will constitute a significant floodplain encroachment or a significant risk to property or life.

The Peter Dierks Joers House (GA0743), located between Station 140+95 and 142+95 left, is listed on the National Register of Historic Places under Criterion C, outstanding example of a Ranch designed in the Moderne as an Style of architecture. Approximately 0.06 acre associated with property will be impacted bγ the project. The State Historic Preservation Officer (SHPO) determined that there would be no the property. The SHPO adverse effect on concurrence in the appendix of the enclosed de minimis Section 4(f) Evaluation.

Noise predictions have been made for this project utilizing the Federal Highway Administration's TNM 2.5 (Traffic Noise Model) procedures. These procedures indicate that noise levels will be above the FHWA noise criteria beyond the

project's proposed right of way limits near the roundabout. These impacts extend approximately 300 feet down the roadway from the roundabout along each leg for a distance of 100 feet beyond the roadway and are the result of the deceleration and acceleration of traffic. Sensitive receptors within this impacted zoneare scheduled to be relocated, resulting in no impacts to sensitive receptors. Noise analysis for the Highway 7 turn lane is not required under ARDOT's Policy on Highway Traffic Noise Abatement, because the construction of turn lanes does not involve added capacity or expose noise sensitive landuses to a new or existing highway noise source. In compliance with Federal guidelines, local authorities will be notified.

The overlay section of this project is within the boundaries of the Hot Springs National Park. No right of way will be acquired, and no impacts to the park are anticipated.

A Public Involvement Meeting was held on March 15, 2018. A synopsis of the meeting is enclosed.



CONCEPTUAL STAGE RELOCATION STATEMENT

GENERAL STATEMENT OF RELOCATION PROCEDURE

Persons displaced as a direct result of acquisition for Job 061547 of the proposed project will be eligible for relocation assistance in accordance with Public Law 91-646, The Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970. The Relocation Program provides advisory assistance and payments to minimize the adverse impact and hardship of displacement upon such persons. No lawful occupant shall be required to move without receiving a minimum of 90 days advance written notice. All displaced persons; residential, business, farm, nonprofit organization, and personal property relocatees are eligible for reimbursement for actual reasonable moving costs.

Construction of the project will not begin until decent, safe and sanitary replacement housing is in place and offered to all affected persons. It is the Department's Policy that adequate replacement housing will be made available, built if necessary, before any person is required to move from their dwelling. All replacement housing must be fair housing and offered to all affected persons regardless of race, color, religion, sex or national origin.

There are two basic types of residential relocation payments: (1) Replacement Housing payments and (2) Moving Expense payments. Replacement Housing payments are made to qualified owners and tenants. An owner may receive a payment of up to \$31,000.00 for the increased cost of a comparable replacement dwelling. The amount of this payment is determined by a study of the housing market. Owners may also be eligible for payments to compensate them for the increased interest cost for a new mortgage and the incidental expenses incurred in connection with the purchase of a replacement dwelling. A tenant may receive a rental subsidy payment of up to \$7,200.00. Tenants may elect to receive a down payment rather than a rental subsidy to enable them to purchase a replacement dwelling. Replacement housing payments are made in addition to moving expense payments.

Businesses, farms and nonprofit organizations are eligible for reestablishment payments, not to exceed \$25,000.00. Reestablishment expense payments are made in addition to moving expense payments. A business, farm or nonprofit organization may be eligible for a fixed payment in lieu of the moving costs and reestablishment costs if relocation cannot be accomplished without a substantial loss of existing patronage. The fixed payment will be computed in accordance with the Code of Federal Regulations and cannot exceed \$40,000.00.

If the displacee is not satisfied with the amounts offered as relocation payments, they will be provided a form to assist in filing a formal appeal. A hearing will be arranged at a time and place convenient for the displacee, and the facts of the case will be promptly and carefully reviewed.

Relocation services will be provided until all persons are relocated or their relocation eligibility expires. The Relocation Office will have listings of available replacement housing and commercial properties. Information is also maintained concerning other Federal and State Programs offering assistance to displaced persons.

Based on preliminary plans, aerial photographs, and an on-site project review, it is estimated that the subject project could cause the following displacements and costs:

The general characteristics of the displacees to be relocated are listed on the Conceptual Stage Inventory Record forms in the back of this report. The general characteristics have been determined by a visual inspection of the potential displacement locations by Relocation Coordinators. The Relocation Coordinators utilize area demographic data, visual inspections, past experiences and knowledge in making this determination.

An available housing inventory has been compiled and it indicates there are at least eighty-nine comparable replacement dwellings available for sale and ten comparable replacement dwellings available for rent within five miles of the project. At least six commercial properties are currently for sale, and ten for lease in the project area. A breakdown of the available properties is as follows:

This project includes highway widening from two to three lanes with curb and gutter and intersection improvements at Highway 5. The units contained in the housing inventory are in the Hot Springs area. The dwellings and number of dwellings are comparable and adequate to provide replacement housing for the families displaced on Job 061547. The housing market should not be detrimentally affected and there should be no problems with insufficient housing at this time. In the event housing cannot be found or can be found but not within the displacees' economic means at the time of displacement, Section 206 of Public Law 91-646 (Housing of Last Resort) will be utilized to its fullest and practical extent.

The housing inventory was compiled from data obtained from real estate companies, web sites, and local newspapers for the subject area. The dwellings contained in the

inventory have been determined to be comparable and decent, safe and sanitary. The locations of the comparable dwellings are not less desirable in regard to public utilities and public and commercial facilities, reasonably accessible to the displacees' places of employment, adequate to accommodate the displacees, and in a neighborhood which is not subject to unreasonable adverse environmental factors. It has also been determined that the available housing is within the financial means of the displacees and is fair housing open to all persons regardless of race, color, sex, religion or national origin consistent with the requirements of 49 CFR, Subpart A, Section 24.2 and Title VIII of the Civil Rights Act of 1968.

A commercial property inventory indicates there are at least sixteen properties available in the subject area at this time. The businesses displaced on Job 061547 may not be able to relocate in the immediate area of their displacement. However, in order to assist the displaced businesses and nonprofit organizations in relocating, the State will explore all possible sources of funding or other resources that may be available to businesses and nonprofit organizations. Sources that will be considered include: State and Local entities, the Department of Housing and Urban Development, the Economic Development Administration, the Small Business Administration and other Federal Agencies. Emphasis will be given in providing relocation advisory services to the businesses and nonprofit organizations. Appropriate measures will be taken to ensure that each entity displaced is fully aware of their benefits, entitlements, courses of action that are open to it, and any special provisions designed to encourage businesses and nonprofit organizations to relocate within the same community.

It is estimated that there will be two residential tenant displacements on this project. The two displaced households are estimated to be low income households. One displaced household is also estimated to include one large minority family. All displacees will be offered relocation assistance under provisions in the applicable FHWA regulations. At the time of displacement another inventory of available housing in the subject area will be obtained and an analysis of the market made to ensure that there are dwellings adequate to meet the needs of all displacees. Also, special relocation advisory services and assistance will be administered commensurate with displacees' needs, when necessary. Examples of these include, but are not limited to, Housing of Last Resort as previously mentioned and consultation with local officials, social and federal agencies and community groups.

There are no other identified unusual conditions involved with this project.

The Service has reviewed your assessment and determinations for Arkansas Department of Transportation (ArDOT) Job Number 061547, Garland County, Arkansas. The project was described and assessed as follows (abbreviated):

The Arkansas Department of Transportation (ArDOT) is proposing to widen Highway 7 to three lanes with curb and gutter and install an interchange/roundabout at the Highway 7 and Highway 5 intersection. Please see attached kmz file for current design.

A review of IPaC for the proposed project location shows the following federally listed species have the potential to occur: northern long-eared bat (Myotis septentrionalis), Pink Mucket (Lampsilis abrupta), Rabbitsfoot (Quadrula cylindrica cylindrica), Arkansas Fatmucket (Lampsilis powellii), harperella (Ptilimnium nodosum) and Missouri bladderpod (Physaria filiformis). A 'no effect' determination was made for the federally listed mussel and plant species due to the lack of habitat.

The Final 4(d) Rule and Programmatic Biological Opinion (BO) applies to the project's activities that have the potential to affect northern long-eared bats. The Final 4(d) Rule exempts the incidental take of northern long-eared bats from take prohibitions in the Endangered Species Act. The exemptions apply as long as the activities do not occur within 0.25 mile of a known hibernaculum or within 150 feet of a known occupied maternity roost from June 1 to July 31. No known hibernacula or maternity roosts exist within the project limits. Although approximately 15 acres of forested habitat will be cleared for this project, a winter clearing restriction will be included in the job contract, which prohibits tree clearing between April 1st and November 15th. Please see the 4(d) Rule Streamlined Checklist.

We request your concurrence in our determination.

Due to the limited size of the area being cleared off the existing roadway and within right of way, habitat types, distance to known species locations, and the special provision for winter clearing bat avoidance and stream conservation measures, the Service agrees with your assessments.

The Service has reviewed your determination that the proposed action will not result in any prohibited incidental take for Northern Long-eared Bat. This project may affect the Northern Long-eared Bat; however, there are no effects beyond those previously disclosed in the Service's programmatic biological opinion for the final 4(d) rule dated January 5, 2016. Any taking that may occur incidental to this project is not prohibited under the final 4(d) rule (50 CFR §17.40(o)). This project is consistent with the description of the proposed action in the programmatic biological opinion, and the 4(d) rule does not prohibit incidental take of the Northern Long-eared Bat that may occur as a result of this project. Therefore, the programmatic biological opinion satisfies the "action agency" responsibilities under ESA section 7(a)(2) relative to the Northern Long-eared Bat for this project.

Please keep in mind that you must report any departures from the plans submitted; results of any surveys conducted; or any dead, injured, or sick Northern Long-eared Bats that are found to this office. If this project is not completed within one year of this letter, you must update your determination and resubmit the required information.

What is Section 4(f)?

Section 4(f) is part of a law that was passed to protect public parks, recreation areas, wildlife and waterfowl refuges, and important historic sites from being harmfully affected by transportation projects.

Does Section 4(f) Apply to the Peter Dierks Joers House?

The Peter Dierks Joers House (Figure 1) is on the National Register of Historic Places. The construction design minimizes the effect upon the Peter Dierks Joers House and adheres to the National Environmental Policy Act (NEPA). The proposed project is documented with a Tier 3 Categorical Exclusion.



Figure 1. The Peter Dierks Joers House

After we do an evaluation such as this, some Section 4(f) impacts can be recognized as "de minimis," which means relatively minor. We will present information to prove that there are no undesirable impacts to the Peter Dierks Joers House. We can use a De Minimis Section 4(f) Evaluation on projects that meet the conditions shown in Table 1.


What is the proposed road project?

The ARDOT, in conjunction with the FHWA, proposes to make safety improvements to a portion of Highway 7 from Highway 7 Spur to Highway 5 in Garland County, as shown in Figure 2. The proposed highway improvements will overlay approximately 0.47 mile at the beginning of the job, then widen the remainder of the project to three lanes with curb and gutter, and add a roundabout at the Highways 7/5 intersection. The total project length is approximately 4.3 miles.

Why is the Peter Dierks Joers House Important?

The Peter Dierks Joers House is located at 2111 Park Avenue (Highway 7), three miles north of downtown Hot Spring in Garland County. It is listed on the National Register of Historic Places under Criterion C as an outstanding example of a Ranch designed in the Modern style of architecture. The property embodies the distinctive characteristics of construction for a Mid-Century Modern ranch style house. The property consists of a Ranch style house, garage, swimming pool, well house, and rock entrance with a rock fence.

The house was designed by architect E.A. Sibley, and built in 1955 by Hal Anderson. The house has maintained its architectural integrity and conveys the form and function for which it was designed. This home is one of the most intact homes of this style in the state and one of only a few architect designed Ranch homes known in the state.



Can We Avoid the Peter Dierks Joers House?

Efforts were made by the Department to minimize impacts while allowing construction of the widened roadway (Figure 3). However, it was not feasible to widen the roadway to the other side because of an unnamed creek located there. The Peter Dierks Joers House property cannot be avoided due to the widening required for this portion of the project.

What Will the Project Do To the Peter Dierks Joers House?

The proposed project will not directly impact the Peter Dierks Joers House or associated features, and visually there will not be much change (if any) in the view from the house. The entrance to the driveway is obscured by landscape and a rock wall. No adverse impacts to the property are expected as a result of this project. An archeological survey of the proposed right of way area did not locate any artifacts or intact deposits.

Approximately 0.06 acre will be acquired from the front of the property for new right of way (Figure 3). No temporary construction easements will be needed. The driveway of the residence will be connected to the highway during construction to improve the sight distance for emerging into traffic. The rock wall will not be affected.

What Did We Do to Reduce Harm to the Peter Dierks Joers House?

The following measures were included in the proposed project to reduce harm to the Peter Dierks Joers House:


• The proposed right of way was moved off of the property as far as possible to minimize impacts.

Who Did We Involve In This Evaluation?

The State Historic Preservation Officer (SHPO) has been involved in reviewing the information relating to the Peter Dierks Joers House. The SHPO has agreed that this project will have no adverse effect on the House and property. A copy of this conclusion is included in Appendix A.

What is the Decision?

We believe this evaluation shows that the proposed roadway improvements will not harm the protected features or qualities that make the historic site important under Section 4(f), thus qualifying for a de minimis finding on the Peter Dierks Joers House.

An open forum Public Involvement meeting for the proposed widening of Hwy. 7 from its intersection at Hwy. 7S to Hwy. 5 was held at the Living Word Worship Center of Hot Springs (Fellowship Hall) in Hot Springs National Park, Arkansas from 4:00 - 7:00 p.m. on Thursday, March 15, 2018. Efforts to involve minorities and the public included:

- Display advertisement in *The Sentinel Record* on Sunday, March 4, 2018 and Sunday, March 11, 2018.
- PSA (Public Service Announcement) ran in Cumulus Power 92.3 FM from Monday, March 12, 2018 through Thursday, March 15, 2018.
- Spanish PSA ran in La Zeta 106.3 FM from Monday, March 12, 2018 through Thursday, March 15, 2018.
- Outreach letters mailed to Public Officials.
- Distribution of flyers in the project area.

The following information was available for inspection and comment. Small-scale copies of the displays are attached.

- Displays included two aerial photographs at a scale of 1 inch = 600 feet, illustrating the alignment.
- Preliminary design of the proposed project at a scale of 1 inch = 100 feet.
- Lap top computer with projection screen showing how roundabouts function.

Handouts for the public included a comment sheet and a small-scale map illustrating the project area. Copies of these are attached.

- Four individuals were concerned that their septic systems will be impacted.
- Two individuals wanted to widen the bike lanes to 5 feet.
- Three individuals were concerned that the additional right of way taking would severely impact their property.
