The Environmental Division has reviewed the referenced project and it falls within the definition of the Tier 3 Categorical Exclusion as defined by the ARDOT/FHWA Memorandum of Agreement on the processing of Categorical Exclusions. The following information is included for your review and, if acceptable, approval as the environmental documentation for this project.

The purpose of this project is to replace two bridges on Highway 78 in Lee County. The total length of the project is 0.49 mile. A project location map is enclosed.

Highway 78 consists of two 10-foot paved lanes and 4-foot gravel shoulders. The existing right of way width is 80 feet.

The bridge at McNulty Lake will be replaced with a bridge located on the north side of the existing bridge. The bridge at Hog Tusk Creek will be replaced with a box culvert on the north side of the existing bridge. The new approaches will have two 10-foot wide paved travel lanes with 4-foot wide paved shoulders. The new right of way width will be 120 feet at both locations.

Design data for this project is as follows:

There are no relocations or environmental justice issues associated with this project. Field inspections found no evidence of existing underground storage tanks or hazardous waste deposits. A maximum of 3.9 acres of new right of way will be required to construct this project, of which a maximum of 1.03 acres is prime farmland and a maximum of 2.16 acres is Farmland of Statewide Importance. Form NRCS-CPA-106, the Farmland Conversion Impact Rating, is attached. No impacts to cultural resources are anticipated; concurrence from the State Historic Preservation Officer is enclosed.

The replacement of the existing bridge over Hog Tusk Creek with a 12' x 10' x 55' quintuple reinforced concrete box culvert will impact a maximum of 1.01 acres of palustrine forested wetlands and less than 0.1 acre of Hog Tusk Creek. The replacement of the existing bridge over McNulty Lake with a new bridge structure will impact a maximum of 1.1 acres of palustrine forested wetlands. Compensatory mitigation will be provided for the unavoidable impacts to wetlands. Construction of the proposed project should be allowed under terms of a Section 404 Nationwide 23 Permit for Approved Categorical Exclusions as defined in the Federal Register 82(4):1860-2008.

The official species list obtained through the U.S. Fish & Wildlife Service (USFWS) Information for Planning and Consultation website found one threatened species, Piping Plover (*Charadrius melodus*) and one endangered species, pallid sturgeon (*Scaphirhynchus albus*) listed for the project area. Due to the lack suitable habitat for either species in the project area, and distance to any known species locations, it was determined that the project will have no effect on listed species.

Lee County participates in the National Flood Insurance Program. The project lies within the Zone A, Special Flood Hazard Area. The final project design will be reviewed to confirm that the design is adequate and that the potential risk to life and property are minimized. Adjacent properties should not be impacted nor have a greater flood risk than existed before construction of the project. None of Job Number 110616 Tier 3 Categorical Exclusion Page 3 of 3

the encroachments will constitute a significant floodplain encroachment or a significant risk to property or life.

Noise predictions have been made for this project utilizing the Federal Highway Administration's TNM 2.5 (Traffic Noise Model) procedures. These procedures indicate that noise levels are below the FHWA noise criteria beyond the project's proposed right of way limits. Any increases in roadway noise levels will not be the result of the proposed project, but instead a result of traffic volume increases during the planning period (Year 2039). Therefore, any noise level increases will occur independently of this proposed project, and no project related noise impacts are anticipated. In compliance with Federal guidelines, local authorities will not require notification.
