Attention all retirees, if you move, please notify Lacey Cole who replaced Emily Boggs (Happy Retirement, Emily!) at the Arkansas State Highway Employees' Retirement Office at (501) 569-2413. Besides keeping your address current, you also need to keep your beneficiaries current. You should contact the Group Insurance Office at (501) 569-2417 for beneficiary updates on your group health or life insurance. Since 2001, the Retirement System provides an additional lump-sum benefit of \$7,500 payable to your beneficiary at the retiree's death. If you have any questions about this benefit or the beneficiary for this benefit, please call (501) 569-2532.

#### **DISTRICT SIX**

**September 2017** - District 6 Retirees met September 11, 2017; our speaker for the Meeting was Jessie Jones, ARDOT Division Engineer – Transportation Planning & Policy and Greg Nation, ARDOT Public Transportation Administrator. The ARDOT completed a twenty year strategic transportation plan in July 2017; the plan recognized \$50 billion in needs but also showed a large gap between these needs and expected funds. These needs were general needs not specific projects. A ten year study is going to the Transportation Commission shortly which will include corridor studies as well as projects studies.

**October 2017** - District 6 Retirees met October 2, 2017 our speakers for the Meeting were Shana Chaplin, Department of Human Services (DHS)-AR Office of Communications and Community Engagement and Ezell Breedlove, Department of Human Services-AR Office of Communications and Community Engagement. Shana explained that this Office of DHS was reorganized a year ago to help potential volunteers know or recognize legitimate organizations needing volunteers. A computer site was established listing organizations vetted by the Office. Ezell oversees the website for registered volunteers, volunteerAR.org. No fundraising is permitted on the site and organizations must be an IRS 501c approved organization and have liability insurance for volunteers.

**December 2017** - District 6 Retirees met December 4, 2017, speaker for the Meeting was Michele Jakacki, a Registered Dietician with Baptist Health; she is primarily involved in Diabetes Education and nutrition in healthy adults. Michele explained that as we age we should be mindful of our diet and the foods in our diet. To maintain a healthy body weight and keep a good energy level we should insure we get the correct amounts of carbohydrates, proteins, fats, water, and fiber. By the summer of 2018, food labeling (Nutrition Facts) should have Total Calories and Serving Size emboldened on the label; the label should also indicate the amount of "Added Sugars". Items to remember are keeping a healthy balance of food stuffs and eat in moderation.

January 2018 - District 6 Retirees met January 8, 2018, speaker for the Meeting was Shane Lind, Museum Program Coordinator at the MacArthur Museum of Arkansas Military History; the Museum was created to interpret our state's military heritage from its territorial period to the present. Located in the historic Tower Building of the Little Rock Arsenal — built in 1840 as a frontier military post and the birthplace of General Douglas MacArthur (1880) — the museum preserves the contributions of Arkansas men and women who served in the armed forces.

**February 2018** - District 6 Retirees met February 5, 2018, speaker for the Meeting was Doug Hanson, Arkansas Geological Survey. Doug can be contacted at the Arkansas Geological Survey (3815 West Roosevelt Rd, Little Rock) doug.hanson@arkansas.gov. Doug presented a detailed discussion of the geology of the state. This included the various areas of the state: Ozark Plateaus (Northwest Arkansas), Arkansas River Valley, Ouachita Mountains (West Arkansas), West Gulf Coastal Plain (Southwest Arkansas), and the Mississippi River Alluvial Plain (East Arkansas). Each of the areas has their own geologic makeup and present different problems before and after construction.
