REQUEST FOR LETTERS OF INTEREST

Notice is hereby given that the Arkansas State Highway and Transportation Department (Department) is seeking letters of interest from qualified firms for traffic counting activities on public roads in Arkansas. The services will be provided on an as-needed basis for calendar years 2017, 2018, and 2019.

The work will generally consist of the following:

- traffic volume counts,
- vehicle classification counts (with mechanical and video traffic counters),
- intersection turning movement counts with video traffic counters, and
- other traffic data collection as needs demand.

Three (3) sets of paper responses and a copy in PDF format on a Compact Disc (CD) must be received no later than 4:00 p.m. (CDT) on October 21, 2016. Any responses received after that deadline will not be considered.

The consultant selection for this letter of interest will follow the Department's *Consultant Selection Procedures 05/27/2010*. After a review of all letters of interest received, selected firms will be furnished a scope of work and be requested to submit proposals for accomplishing the work. Final selection will be announced following the Arkansas State Highway Commission action in January 2017.
