

This project is a proposal to construct a four-lane fully controlled access highway, designed to Interstate standards, on new location from the Highway 67/Highway 440 Interchange to the Interstate 40/Interstate 430 Interchange. The proposed highway would be 12.7 miles (20.4 kilometers) in length through Pulaski County, Arkansas. Several alternatives were considered including the No-Action alternative.
