Background

The FHWA, in cooperation with the Arkansas Highway and Transportation Department, is rescinding the notice of intent to prepare a Supplemental Draft Environmental Impact Statement (SDEIS) on a proposal to construct the North Belt Freeway, a four-lane, divided, fully controlled access facility located on new alignment in northern Pulaski County.

In 1994, a Final Environmental Impact Statement (FEIS) and a Record of Decision (ROD) identified a selected alignment (1A). However, a portion of this alignment was not compatible with the City of Sherwood's Master Street Plan, and the project was not included in the Transportation Improvement Program (TIP) developed by Metroplan, the responsible Metropolitan Planning Organization (MPO). On February 18, 1999, FHWA published a NOI to prepare a SDEIS as part of the development process for the construction of this proposed freeway project.

The proposed project will primarily serve central Arkansas including Little Rock, North Little Rock, Sherwood, Jacksonville, and northern Pulaski County, Arkansas. The SDEIS was to have addressed a new alignment alternative (1B) proposed by the City of Sherwood and three previously studied alternatives located between the Highway 107/Brockington Road interchange and the eastern boundary of

Camp Robinson near Maryland Avenue and Batesville Pike. The three previously studied alternatives were evaluated in the project's Draft EIS in 1991 and in the project's Final EIS in 1994.

The SDEIS was to focus on a limited study are between Batesville Pike and Brockington Road in northern Pulaski County, since this is the portion of the proposed corridor where several alternative alignments were still being considered. The remaining portions of the selected and approved North Belt Freeway alignment to the east toward Highway 67 and to the west through Camp Robinson ending at the I-40/I-430 interchange were to be reviewed only to a level necessary to document if any substantial changes have taken place since the completion and approval of the project's FEIS and ROD.

A preliminary study of the project alignments completed in 2003 attempted to establish if the local community and MPO could support the originally selected project alternative. The public involvement process associated with this reevaluation indicated public opposition for the originally selected alignment alternative. The City of Sherwood and Metroplan, citing the project's incompatibility with local and regional plans, refused to endorse the originally selected alignment alternative as the locally preferred route. Therefore, an SDEIS will be conducted to evaluate all feasible alternatives, possibly including alignments not evaluated in the project's original DEIS and FEIS. The original NOI for the SDEIS is being rescinded because it limited the area of study. A notice of intent to announce an SDEIS with an expanded study area for this project will be published subsequent to this NOI.

To ensure that the full range of issues related to this proposed action and all significant issues are identified, comments and suggestions are invited from all interested parties regarding this action to rescind the NOI published on February 18, 1999 for the proposed North Belt Freeway. A coordination meeting was held with Camp Robinson (Camp) representatives on March 23, 2004. The meeting addressed the referenced proposed highway project. Lynn Malbrough and Don Nichols from the AHTD along with Randal Looney from the FHWA attended the meeting. Brigadier General Larry Haltom, Colonel William Holmes and several staff members representing environmental, security, and operations at the Camp were present.

General Haltom indicated the proposed route through the Camp was still a viable option, however additional considerations are warranted due to security concerns. Colonel Holmes will review minimum separation distances required between the freeway and sensitive areas in the Camp and advise us of any adjustments that may need to be made. A security fence that will not allow breeching by vehicles will be required through the Camp since the route will run through their cantonment area.

Lieutenant Colonel Steve Payne (with General Haltom's concurrence) asked us to evaluate the feasibility of route to the north of the proposed route. This alternative alignment would be advantageous to the Camp in the following ways:

- The route would be outside the cantonment area of the Camp resulting in less security and safety concerns for the Camp.
- The route would provide a western buffer that would limit urban encroachment into the Camp from the Oak Grove community.
- 3. The area along the route does not have any history of ammunition ranges or landfills. This fact could serve to limit the Camp's potential liabilities.

This new alignment would have the following advantages to the AHTD:

- 1. It would eliminate several grade separations that would be required for existing alignment. (approximately four fewer grade separations)
- 2. Lower cost security fencing would be required.

> It would better serve the Gibson and Oak Grove communities, however, the interchange with Batesville Pike would be further north away from North Little Rock.

We committed to the Camp that we would generate a traffic forecast for the new proposed route to determine if it warrants further environmental analysis. Kit Carson is currently in the process of generating the alignment for the Planning Division to do a traffic forecast.



## **Modifications of Alternative Alignments**

North Belt Freeway (AHTD Job # R60101) SDEIS Public Officials Meeting 1/12/06

#### **Background**

The alternative alignments presented at the Public Officials Meeting on 11/9/05 were displayed at Public Involvement Meetings on 11/14/05 and 11/15/05. Preliminary environmental constraints were mapped in the project area and traffic model runs were conducted. Analyses of public comments and preliminary constraints have resulted in recommended modifications to the original alternative alignments. Results of the analyses and associated modifications are presented below.

Shift segment 10 to the north to create larger contiguous block of land

#### Southern Alignment

#### Results

Highest level of support from the public

#### Modification:

Proposal for interchange at Kellogg Rd. was changed to a grade separation to be consistent with the other alignments as they cross Kellogg Rd.

#### PROJECT HISTORY

1994 - An Environmental Impact Statement (EIS) was completed and a Record of Decision was obtained for a selected alignment.

1997 - The EIS expired and required reevaluation after Metroplan did not include the North Belt Freeway in the Transportation Improvement Plan.

2003 - A reevaluation was completed and the originally selected alignment was upheld as the Department's preferred route.

2004 - A Supplemental Draft Environmental Impact Statement (SDEIS) was initiated after it was determined that the Department's previously preferred alignment was opposed by Metroplan, the City of Sherwood and the public.



An open forum public involvement meeting for the proposed North Belt Freeway (Hwy. 67 – I-40 West) was held at the Brockington Church of the Nazarene in Sherwood on November 14, 2005 and at Cato Elementary on November 15, 2005. News releases and flyers were utilized to inform the public of the meetings.

The following information was available for inspection and comment:

- Seventeen displays including aerial photographs illustrating the alignments, line maps illustrating the alignments, and information boards
- Handouts for the public included a comment sheet and a small-scale map illustrating the alignment locations

Attendance at the public involvement sessions was 489. Approximately 81 comment forms were received during the meeting. One hundred and eighty-seven comment forms were later received through the mail along with 13 comments by e-mail.

The information obtained by the 281 surveys related to support for the project, alternative alignment and interchange preferences, and concerns or issues related to the project and alternative alignments.

#### SUPPORT FOR THE NORTH BELT FREEWAY

259 respondents supported the construction of a new highway through the area

249 respondents supported the construction of a 4-lane interstate type facility

#### ALTERNATIVE ALIGNMENT AND INTERCHANGE PREFERENCES

The question on the survey asking if the respondents preferred one alternative alignment to any of the other alternative alignments received 270 responses. Results of the alternative alignment are presented below by which segment number crossing Kellogg Road. was chosen. The major difference between the alternative alignments is where they cross Kellogg Road.

Alternative alignments utilizing segments 4 or 5 provided the option of continuing east either to the north or south of Gravel Ridge. Of the 104 respondents choosing segment 4 or 5, 60 of them selected an alignment south of Gravel Ridge. For the alignments north of Gravel Ridge, segment 12 was preferred by 29 respondents and segment 11 was preferred by 14 respondents.

For the crossing of Fears Lake along the southern alignments, segment 13 was preferred by 148 respondents, and segment 14 was preferred by 48 respondents.

The preference for an interchange at Oneida Road was mentioned by 38 respondents, and preference for a grade separation (only) at the same location was mentioned by 3 respondents. The public produced an additional comment form related specifically to the justified need for an interchange at Oneida Road. Twenty-five of these comment forms have been received to date.

#### COMMENTS, CONCERNS AND ISSUES

Most comments received were individual concerns such as loss of homes and property, depreciation of property value, increase of air and noise pollution, and the possible increase of crime. Increased traffic volume was an issue that would make the neighborhoods unsafe and endanger the lives of children and wildlife. Some comments reflected the history of their homesteads that could not be replaced. Comments were also received from new landowners who just purchased property this year.

The summary of comments listed below reflects the personal perception or opinion of the person or organization making the statement. The sequencing of the comments is random and is not intended to reflect importance or numerical values.

The following general comments reflect the **positive** issues associated with the proposed North Belt Freeway:

- Project would ease traffic congestion along Hwy. 67 and make it safer.
