 - Limitations on Usage
 - Handling Limitations/Warnings
 - Safety Data Sheet (SDS)

• Destination samples will also be taken as deemed necessary to assure compliance with specifications. Failure of these samples may be considered sufficient cause to reject the material and suspend further use and/or removal from this QPL until tests by the Department determine that the producer's product is in compliance with applicable specifications and requirements. Approval may be withdrawn if field performance is unacceptable.

The manufacturer of privately labeled products must be disclosed.
