ARKANSAS HIGHWAY COMMISSION APPROVES BID FOR IMPROVEMENTS IN DALLAS COUNTY

LITTLE ROCK (7-29) -- The Arkansas State Highway Commission approved a bid for improvements to roadways in Dallas County, according to the Arkansas State Highway and Transportation Department (AHTD) officials and County Judge Jimmy Jones.

The purpose of the project is to resurface 1.8 miles of County Roads 2 and 71 in Dallas County.

The work on County Road 2 (Dallas Co. Road 246/Nix Ferry Road) will extend from County Road 273 to Ferry Camp Road.

The work on County Road 71 (Dallas Co. 301) will extend one mile south of Highway 9, south of Tullip.

C&F Construction Company, Inc. of Smackover, AR was awarded the contract at \$261,504.96.

This county road project is funded through the State Aid Road Program established by the legislature and administered by the State Aid Division of the Arkansas State Highway and Transportation Department. This Program provides approximately \$20 million annually from the state motor fuels tax to assist counties with projects of their choosing on the county road system.

Construction is scheduled to begin in two to four weeks, weather permitting. The project will be complete this fall.

ARKANSAS HIGHWAY COMMISSION APPROVES BID FOR IMPROVEMENTS IN DALLAS COUNTY

LITTLE ROCK (7-29) -- The Arkansas State Highway Commission approved a bid for improvements to roadways in Dallas County, according to the Arkansas State Highway and Transportation Department (AHTD) officials and County Judge Jimmy Jones.

The purpose of the project is to resurface 2 miles of County Roads 6 and 48 in Dallas County.

The work on County Road 6 (Dallas Co. 236) will extend from Highway 7 to County Road 241, north of Sparkman.

The work on County Road 48 (Dallas Co. 126) will extend from Highway 229 to Dallas County Road 115, north of Fordyce.

C&F Construction Company, Inc. of Smackover, AR was awarded the contract at \$133,944.30.

This county road project is funded through the State Aid Road Program established by the legislature and administered by the State Aid Division of the Arkansas State Highway and Transportation Department. This Program provides approximately \$20 million annually from the state motor fuels tax to assist counties with projects of their choosing on the county road system.

Construction is scheduled to begin in two to four weeks, weather permitting. The project will be complete this fall.
