Transportation Alternatives Program and Recreational Trails Program Applications Now Available

LITTLE ROCK (November 30, 2014) – The Arkansas State Highway Commission is pleased to announce the first application cycle for the Arkansas Transportation Alternatives Program (TAP) and a call for the Recreational Trails Program (RTP) applications.

TAP was authorized by the most recent Federal transportation funding act, Moving Ahead for Progress in the 21st Century Act (MAP-21). TAP redefines the former Transportation Enhancement activities and consolidates these eligible activities with the former Safe Routes to School (SRTS) program and projects previously funded though the discretionary National Scenic Byways program.

A seminar will be held on January 22, 2015 and another on February 19, 2015 at the Arkansas State Highway and Transportation Department (AHTD) Central Headquarters building at the address listed below to inform potential eligible sponsors of TAP and RTP requirements and responsibilities. Eligible TAP projects include, but are not limited to:

- Construction of on-road and off-road trail facilities for pedestrians, bicyclists, and other non-motorized forms of transportation, including sidewalks, bicycle infrastructure, pedestrian and bicycle signals, lighting and other safety-related infrastructure.
- Construction of infrastructure-related projects and systems that will provide safe routes for non-drivers.
- Conversion and use of abandoned railroad corridors for trails for pedestrians bicyclists, or other non-motorized transportation users
- Any environmental mitigation activity, including pollution prevention and abatement activities.
- Infrastructure-related SRTS projects:
 - Sidewalk improvements, traffic calming and speed reduction improvements.
 - Pedestrian and bicycle crossing improvements.
- Non-infrastructure related SRTS projects:
 - Public awareness campaigns and outreach.
 - Enforcement, encouragement and evaluations programs.
 - Bicycle & Pedestrian education or a walking school bus program in the vicinity of a K-8 school.

MAP-21 provides RTP funds for projects such as the construction and major maintenance of motorized, non-motorized, and multiple-use recreational trails, development and rehabilitation of trailside and trailhead facilities and trail linkages.
