ARDOT IDENTIFIES PREFERRED ALTERNATIVE FOR STATE HIGHWAY 10 IMPROVEMENTS FROM PLEASANT RIDGE ROAD TO PLEASANT VALLEY DRIVE

PULASKI COUNTY (9-21) – A Preferred Alternative for the State Highway 10 (Cantrell Road) improvement project from Pleasant Ridge Road to Pleasant Valley Drive in Little Rock has been identified, according to Arkansas Department of Transportation (ARDOT) officials.

Following a review of the comments received from a Public Involvement Meeting held on March 30, the Single Point Urban Interchange (SPUI) has been identified as the Preferred Alternative for operational improvements to State Highway 10 from Pleasant Ridge Road to Pleasant Valley Drive. 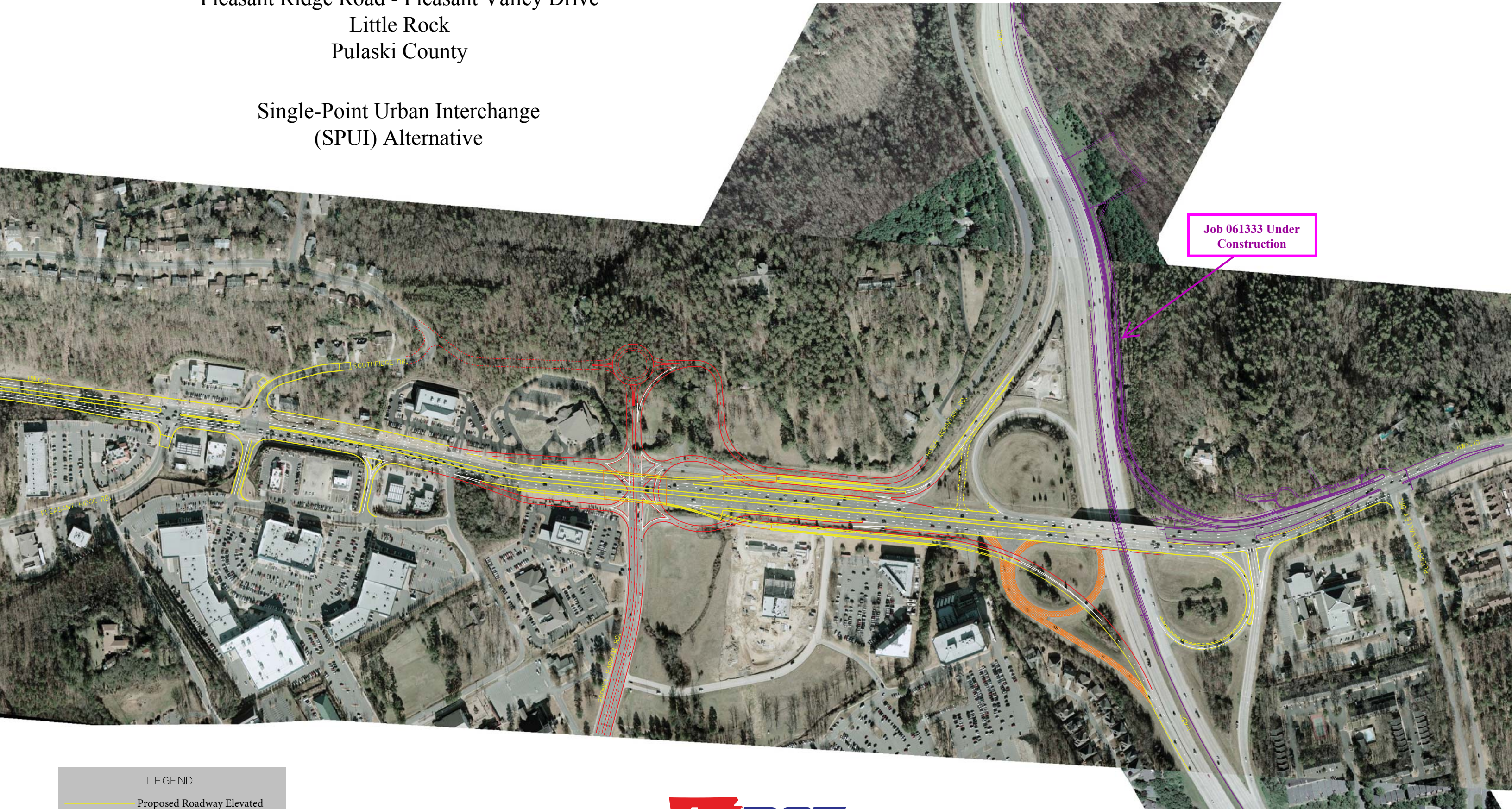
