Department Seeking Public Input about Proposed Widening of Highway 112 in Benton County

BENTON COUNTY (12-10) - The Arkansas Department of Transportation (ARDOT) will conduct an online public involvement meeting about the proposed widening of Highway 112 between Highways 612 and 12 through the cities of Springdale, Cave Springs, Rogers, and Bentonville in Benton County.

The public is invited to listen, view meeting materials, and provide written comments. The website will be available for comments until 4:30 p.m. on Friday, January 1. Citizens will have an opportunity to ask questions and make comment during a "live" virtual presentation from 5:30 p.m. to 6:30 p.m. on Thursday, December 17.
