## NEW ACCOUNTING SYSTEM ON THE BOOKS

In the last Centerline edition, we introduced our new Oracle Enterprise-wide Financial System that will benefit all ARDOT employees. In this edition, we want to update you on the progress we are making.

We are developing ARDOT's system with a continuous improvement approach—this means that the team develops the system in steps, improving on the functionality each time. Our core leads from ARDOT, working with our CherryRoad implementer, have developed and reviewed the first example of what the system will look like. We are excited about what we are seeing!


We are committed to creating a system that makes sense and feels familiar to ARDOT employees while taking advantage of Oracle Cloud offerings. We have maintained our General Ledger accounts with only slight updates (for those of you who work with these accounts). For our larger audience, expense reimbursement will be performed through the system. To ease the process of submitting requests, we will have the capability to include rules that check that the expense meets our policies. The system then generates notifications to expedite the approval process.

There will also be standards to establish purchasing, grants, and contracts and bar code scanning solutions for stock inventory. Our leads have reported that Oracle is very user-friendly, resulting in more automation and less paper in the future.

We also want to remind you that each District and Division



has a Change Champion whose role is to keep you informed, allow you to provide feedback, and answer any questions you may have. If you have not met your Change Champion, or are not certain who it is, please reach out to Paulette Rice at Paulette.Rice@ardot.gov to find out. Stay tuned!





## IMPORTANT HEALTH INSURANCE REMINDERS

It's once again that time of year to start planning for open enrollment. Open enrollment for the 2020 health insurance plan year will be from October 1 – 31, 2019.

Employees are able to make the following changes during open enrollment:

- Enroll into the plan
- Add/drop spouse and/or dependents
- Change plan level
- Cancel coverage

Members who do not elect any changes during open enrollment will keep their current coverage for the 2020 plan year. Changes made during enrollment go into effect January 1, 2020

Please remember to do your online health assessment, your wellness visit, and enroll in the tobacco cessation program (if applicable) by October 31, 2019.

## **COMPLETE YOUR ONLINE HEALTH ASSESSMENT!**

Be sure you have completed your Online Health Assessment for this year. It must be completed by October 31 through the Health Advantage My Blueprint portal. Members who need assistance accessing their My Blueprint account can contact Health Advantage at 1-800-482-8416.

Here are instructions for completing your assessment:

1) Go to myblueprint. healthadvantage-hmo.com, or click the Sign In icon on the Health Advantage homepage at healthadvantage-hmo.com to sign in or create an account.

- 2) After accessing My Blueprint, click the Menu icon at the top left corner of the page. Select the Healthy Living link located in the Health & Wellness section of the menu.
- 3) Once the Healthy Living tab is selected, click the button to go to the HealthConnect Blue dashboard. The first time HealthConnect Blue is accessed, terms and conditions will need to be accepted on the next page.
- **4)** After the terms and conditions are accepted, members will go to the HealthConnect Blue dashboard

and can access the link for the online health assessment.

5) Upon completion of the health assessment, members will receive a personal plan to improve their health.

Members who test positive for nicotine will once again be able to successfully complete the wellness program by completing one of the tobacco cessation programs before October 31, 2019. ## AHP INSPECTION COMPETITION



## 2019: TRANSPORTATION CONFERENCE & EQUIPMENT EXPO

New ideas in the field of transportation provided the focus for the 108th Transportation Conference and Equipment Expo presented by ARDOT's Transportation Research Committee. A total of 286 ARDOT employees, consultants and transportation officials gathered at the Hot Springs Convention Center in August to learn about new cutting-edge technologies, policies and

procedures when it comes to the world of research.

"We had a record-breaking turnout despite having to reschedule the conference due to the historic flooding in June," Staff Research Engineer Elisha Wright-Kehner commented.

"This conference allows for transportation professionals to be exposed to multiple innovative topics across the transportation field. Officials can network and share experiences that foster future innovation."

The focus of the conference was research as it applies to highways—how we build them, repair them, those who use them and the challenges and changes to be faced in the world of transportation as we plan for the future.

The conference kicked off with multiple workshops covering pavement preservation, transportation management plans and mainstream ethical issues that frequently arise in all phases of transportation engineering practice. General sessions provided an opportunity to learn more about recovery from natural disasters

such as that experienced by the North Carolina Department of Transportation where recent storms left damages totaling nearly half a billion dollars. Participants also heard from the Texas Department of Transportation and how their teams dealt with Hurricane Harvey.

In the days that followed, participants attended sessions to learn more about pavement preservation, ARDOT's new Traffic Management Center, Single-Point Urban Interchanges, the effects of tree canopy on highway pavements, smarter work zones, accelerated bridge construction and much more.

When not attending sessions, participants had the opportunity to visit with representatives from 39 design and construction companies who had booths in the exhibitors' area of the conference.

"The inclusion of the equipment expo to this year's TRC lineup proved to be a valuable addition," Wright-Kehner added. "ARDOT's Equipment Managers are planning to have their summer annual meeting in combination with the TRC Conference next year as well."

## BLANKENSHIP RECEIVES PATRIOT AWARD

The Employer Support of the Guard and Reserve (ESGR) surprised District One Staff Engineer Ryan Blankenship with the Patriot Award on July 25.

ESGR is a Department of Defense organization established to promote cooperation and understanding between Service members and their civilian employers and to assist in the resolution of conflicts arising from the employee's military commitment.

The award is presented to employers or supervisors who show support for members of their staff that are serving in the National Guard or Reserve. Recipients show their support of those employees through a wide range of measures including flexible schedules, time off prior to and after deployment, caring for families and granting leaves of absence if needed.

Blankenship was nominated for the award by Engineer Cody Bennett in the RE 13 Office in Wynne. In addition to his career with ARDOT, Bennett has served in the National Guard for just over ten years.

"I felt Ryan deserved this honor because he has been very accommodating when I have had to leave ARDOT to go on military orders." Bennett shared. "I have only been with ARDOT for two and a half years and have been called on orders totaling nearly a year of that time. Usually when I have to leave, it comes with very short notice and little time for Ryan to prepare to cover my absence. Not to mention when I do leave, it has commonly been during our busiest time of the year. When I am called to orders, he asks my family to let him know if

we need anything. Some employers might become frustrated with an employee being in and out with the Guard like I am, but since I have been working here I never receive any downgrade in work environment or relations within the office. When I come back from orders, I get filled in on what I missed or what has changed, and work continues as if I had never left. The whole office pitches in when I leave and covers down on my responsibilities like its second nature for them, no questions asked, or complaints. Resident Engineer Office 13 has been a great work environment since the start and I couldn't ask for better."

The award was presented to Blankenship by Elvin Tate, Employer Initiative Program Director for ESGR and James Pulliaum, Military Outreach Director for ESGR.

## ARDOT PLACES 3RD AT REGIONAL ROADEO



## ARDOT WINTER WEATHER POLICY

Gone are the hot days of summer. With cooler weather here and winter approaching, here is a reminder of ARDOT's Winter Weather Policy.

The Department's primary mission centers around maintaining safe highways for the traveling public and our responsibilities during winter storms are critical to that mission. Therefore, the Department does not suspend its operations due to inclement weather.

Essential personnel are expected to report to work for their regular schedule or a modified inclement weather schedule, even in situations when the Governor declares State offices are closed due to inclement weather. When winter weather is predicted, essential personnel are required to provide a phone number where they can be reached during non-working hours. Employees may use this on-call time to engage in personal activities of their choosing, but they must be accessible by telephone at all times and able to report for duty within one hour of notification.

When the severity of weather conditions causes State offices to be

officially closed, dismissed early or have a delayed opening, non-essential personnel should look for information on closings on local radio and television stations. Employees may also access the Arkansas State Government website at www.arkansas.gov for the most up-to-date information regarding office closings or call the Governor's inclement weather line at 501-682-2ICE (2423).

When the Governor declares that the Inclement Weather Policy is in effect, this usually means there will be a delayed start due to bad weather conditions, typically two hours. The number of inclement weather hours granted will be calculated in relation to the announced delayed start time and 8:00 a.m. In these situations, non-essential employees are expected to report to work no later than the delayed start time, which is typically 10:00 a.m. unless otherwise specified. Non-essential employees who work a flexible schedule other than 8:00 a.m. to 4:30 p.m. should adjust their arrival time accordingly. Those who report to work after the

delayed start time or who do not report to work at all, will be charged a combination of inclement weather hours and annual leave.

When the Governor or Director declares an early dismissal due to inclement weather conditions, non-essential employees will be notified that they may leave work early. The number of hours of inclement weather leave granted to employees on such days will be based on the time of dismissal in relation to 4:30 p.m. Those who depart before the official dismissal time will be charged a combination of inclement weather hours and annual leave from the time they depart to the official dismissal time.

When State offices are closed for an entire day due to inclement weather, non-essential employees are not expected to report to work. On those occasions, all employees will be granted eight hours of inclement weather leave.

## VOLUNTEERS PROVIDE HELP IN EMERGENCIES

"Be Prepared." That is the motto of the Boy Scouts of America and also perfectly sums up the role of two volunteer groups at the Department — ARDOT's Emergency Response Coordinators and Assembly Area Coordinators.

#### Who Are They?

This group of 130 volunteers are trained and ready to respond to any disaster or emergency situation that may occur at the Department during work hours. The potential emergencies include such incidents as fires, tornados, earthquakes, bomb threats, active shooter and medical emergencies. The coordinators' job is to make sure any staff member who needs medical attention in an emergency gets help immediately. They also coordinate evacuating ARDOT offices in case of emergency.

Patrick Thomas, ARDOT's Emergency Response Coordinator, has good things to say about these volunteers who make sure things go as smoothly as possible in a chaotic situation.

"The Department is fortunate to have a very good group of volunteers that are really enthused about this program. We have some who have previous military experience or EMT (emergency medical technician) experience. Others received their training when they began the program. They are a great group of volunteers who are level headed and calm, and who can carry out their duties during an emergency."

What are some of the duties of these volunteers? For **Emergency Response Coordinators**:

- If a fire occurs, determine if the fire is on their floor or annex and notify the Radio Room.
- Ensure employees evacuate the building in a quiet and orderly manner.

- Ensure all disabled employees are assisted.
- Sweep the assigned area to make sure all employees have left the building.
- For a tornado or earthquake, check each office and restroom for injured employees and provide care before notifying higher authorities. Then follow evacuation procedures.
- For a bomb threat, follow designated emergency evacuation plans.
- For medical emergencies, call 911, inform the Lobby Security Desk of the emergency location and call the emergency contact for the employee. Proceed with First Aid/CPR training for the emergency at hand.
- For an active shooter, follow training provided by the Arkansas Department of Emergency Management.

## Some duties of the **Assembly Coordinators** are:

- Once employees have reported to their outdoor assembly area, receive reports from the Emergency Response Coordinators as to the status of each floor or annex.
- Direct Division Heads and Section Heads to account for their employees and report any who are missing or injured.
- List injured or missing personnel and request medical assistance for those requiring assistance.
- Report any unusual incidents to higher authorities.
- Keep employees in the assembly area until instructions are received from higher authorities.

Once properly trained, volunteers may keep their position for as long as they wish to perform the duties.

"We lose some volunteers to retirement, others may get promoted within the Department," Thomas explained. "There are some volunteers that started when the program began that are still serving today and they are still just as enthusiastic about it."

### Coming Soon To All ARDOT Employees

Previously in place only at Central Office, the program is expanding. The Department has rolled out Phase Two to include each of ARDOT's ten Districts.

"Initial meetings began this year,"
Thomas shared. "I went to each of
the Districts and explained what the
program was going to offer. They
were very receptive to it. The first
meetings to train volunteers began in
September."

Thomas is excited to see the program grow.

"I am so happy to be a part of what is already in place and now we can extend our services to the Districts. I acknowledge Ken Jordan and Bethany Swindell who laid the foundation for this program in 2007. I want to say thank you to Crystal Woods, Eddie Tanner and Alicia Hunt for giving me the opportunity to lead this program. Last but not least, a special thanks to the volunteers who take the time to perform the duties of these positions. They are the program and without them this valuable resource would not be available to the Department."

Other Departments of Transportation across the country now have similar programs in place.

"I think DOTs across the country understand how important the services of these volunteers are," Thomas stated.

"Our employees are here on a daily basis. There is always the possibility of an injury or incident. These volunteers can provide immediate first aid help while waiting for 911 to arrive. Our volunteers provide that crucial initial response."
