# Service Recognition Bonuses

The Arkansas Highway Commission has authorized Service Recognition payments for 2008. AHTD employees with at least 10 years of qualifying state employment receive the annual service bonuses.

All eligible Department employees will receive a lump sum payment. The state's accounting system (AASIS) requires that the payment of the service award be the same method of payment as the employee's check. If an employee's paycheck is direct deposited, the service payment will also be direct deposited. If the paycheck is mailed, then the service payment will also be mailed.

Social security, federal and state taxes and retirement are withheld from the service bonuses. The payment is based on the total years of state service as of December 2008.

As established by the laws of Arkansas, the amount of an employee's annual service bonus is as follows:

10 – 14 years	\$600
15 – 19 years	\$700
20 – 24 years	\$800
25 year and up	\$900

The service bonuses will be mailed from the State Capitol on November 19th and direct deposited no later than November 20th.

# CONSTRUCTION CORNER

Crews are at work in Texarkana to construct an interchange on new location for Interstate 30 and the Highway 71 relocation around Texarkana. The work represents the beginning of the new loop around the city and is also a part of future Interstate 49.

The job was awarded to Austin Bridge & Road, LP of Dallas, Texas, in January of 2007 for \$34,970,000. Work began in April of that year. In addition to a new interchange on Interstate 30, the project is also constructing the roadway embankment and bridge structures for the Highway 71 relocation extending north of the Interstate to Highway 296 and south of the Interstate to the existing Highway 245 interchange.

The work includes construction of five bridge structures, including a flyover structure that is approximately 65 feet tall and 1,828 feet long. Over two million cubic yards of embankment have been brought onto the construction site. Because the alignment of the project crosses the site of six clay pits, a real challenge on this job has been the draining, undercutting and backfilling of the pits, which cover approximately 11 acres (see top photo). In order to stabilize the clay pit floors, more backfill than was planned for originally had to be brought in.

Completion is expected on the job in late 2009.
