**PROJECT DESCRIPTION:** Beginning in 1991, the City of Maumelle recognized the need for an additional interchange on Interstate 40 and a roadway from Interstate 40 into the city intersecting with State Highway 100 (Maumelle Boulevard).

The City began to identify potential interchange locations, roadway alignments, and impacts. In March 2009, the City hosted a public involvement meeting to listen to the opinions of the public about the preliminary studies. The City has now completed detailed studies of three different potential roadway alignments and two different potential interchange locations. comprehensive Environmental Assessment of the potential impacts associated with each alternative has been completed and accepted by the Arkansas State Highway and Transportation Department and the Federal Highway Administration. Two of the alternatives provide optimal solutions for the additional access and connecting roadway. These alternatives are presented at this hearing and as part of the attached packet. Large scale displays and project information are also available. A copy of the Environmental Assessment is also available for viewing.

The purposes of the new interchange and access roadway are: improve access to the rapidly growing areas of east Maumelle, relieve congestion on Highway 100, relieve congestion at both the I-40/Highway 365 and I-430/Highway 100 interchanges, and improve access for emergency services.

Citizen comments and opinions are now requested to assist with identifying the best alternative to achieve the project purposes. Please review the available information, ask questions of the City staff and their consultant representatives, and then provide your comments on this form.
