The City of Bentonville will conduct an open forum Location Public Hearing to discuss the proposed improvements to 8<sup>th</sup> Street in Bentonville. **The Location Public Hearing will be held on Thursday, December 15, 2011, from 4:00 p.m. to 7:00 p.m., at the Bentonville Downtown Activity Center, located at 215 SW A Street in Bentonville.** At the hearing, participants can review the findings of the Environmental Assessment and learn more about the proposed roadway and interchange improvements. City of Bentonville staff and project team members will be available to answer questions.

Project information will be provided in an open house format; no formal presentation will be made. The public is invited to visit any time during the scheduled hours to view the exhibits, ask questions, and offer comments.
