

NOTICE OF LOCATION AND DESIGN PUBLIC HEARING

The Arkansas State Highway and Transportation Department (AHTD), in conjunction with the Federal Highway Administration (FHWA), will conduct an open forum Location and Design Public Hearing to discuss the proposed alternatives for improvements to Highways 326 and 124 in the City of Russellville. The hearing will be held on Thursday, August 2, 2012, from 4:00 p.m. to 7:00 p.m., at the Calvary Temple Assemble of God (Fellowship Hall), located at 3345 SR 124 in Russellville.

The open forum format allows concerned citizens the opportunity to attend the hearing anytime between the hours of 4:00 p.m. and 7:00 p.m. Representatives of AHTD will be present to answer questions concerning the proposed project. Information on the proposed right of way appraisal and acquisition procedures, as well as the environmental documentation and proposed designs alternatives, will be available at the hearing.

The proposed project is located in the City of Russellville and consists of four alternatives, which include the No Action Alternative, upgrading existing and two New Location Alternatives. AHTD is proposing improvements to portions of Highways 326 and 124 between Hob Nob Road and Crow Mountain Road in Russellville. The purpose of the proposed project is to increase capacity, reduce congestion, and improve safety.

A copy of the Environmental Assessment and the proposed designs of the alternatives are available for public inspection at the Arkansas State Highway and Transportation Department's District Eight Headquarters, 372 Aspen Lane, I-40 exit 81, in Russellville, AR or by contacting the Environmental Division at (501) 569-2281.
