The proposed project is located in the Cities of Bethel Heights, Lowell, Springdale and Rogers and consists of nine alternatives, which include the No Action Alternative. The proposed project will consist of constructing an eastern north-south corridor in northwest Arkansas, extending the existing Highway 265 from Highway 264 north to Highway 94. The purpose of the proposed project is to improve north-south connectivity and to provide an additional avenue of travel north and south without having to access Highway 71B and Interstate 540 in the Northwest Arkansas metro area.
