

## NOTICE OF LOCATION AND DESIGN PUBLIC HEARING

### Job No. 060432 Hwy. 290 – Ouachita River Bridge (Hwy. 7) Garland County

The Arkansas State Highway and Transportation Department (AHTD), in conjunction with the Federal Highway Administration (FHWA) will conduct an open forum Location and Design Public Hearing to discuss the proposed design to widen Highway 7 between Highway 290 and the Ouachita River Bridge (Lake Hamilton) in Garland County.

The Location and Design Public Hearing will be held on Thursday, June 25, 2015, from 4:00 p.m. to 7:00 p.m., at the Baymont Inn & Suites on Lake Hamilton (Conference Center), located at 5321 Central Avenue, in Hot Springs, AR.

The open forum format allows concerned citizens the opportunity to meet with representatives of AHTD, view the proposed design and ask questions concerning the proposed project. Information on the proposed right of way appraisal and acquisition procedures, as well as the environmental documentation, will be available at the hearing.
